## PHILADELPHIA HEALTH AND EDUCATION CORPORATION - COLLEGES OF MEDICINE, PUBLIC HEALTH, NURSING AND HEALTH PROFESSIONS, OPERATION, MAINTENANCE, ETC.

Act of Jul. 12, 2004, P.L. 2013, No. 14A Cl. 84

Making appropriations to the Philadelphia Health and Education Corporation for the Colleges of Medicine, Public Health, Nursing and Health Professions and for continuation of pediatric services.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- Section 1. (a) The sum of \$7,384,000 is hereby appropriated to the Philadelphia Health and Education Corporation for the College of Medicine for the fiscal year July 1, 2004, to June 30, 2005, for instruction in the Doctor of Medicine program.
- (b) The sum of \$1,635,000 is hereby appropriated to the Philadelphia Health and Education Corporation for the Colleges of Medicine, Public Health, Nursing and Health Professions for the fiscal year July 1, 2004, to June 30, 2005, for the general maintenance of the Colleges of Medicine, Public Health and Nursing, including the Allied Health, Professions and Graduate Schools, and for student aid.
- (c) The sum of \$292,000 is hereby appropriated to the Philadelphia Health and Education Corporation for the fiscal year July 1, 2004, to June 30, 2005, for minority educational and recruitment programs.
- (d) The sum of \$712,000 is hereby appropriated to the Philadelphia Health and Education Corporation, for the fiscal year July 1, 2004, to June 30, 2005, for continued pediatric outpatient and inpatient treatment of severe physically disabling diseases.
- (e) The sum of \$149,000 is hereby appropriated to the Philadelphia Health and Education Corporation, for the fiscal year July 1, 2004, to June 30, 2005, for continued support of the handicapped children's clinic.
- (f) The sum of \$1,914,000 is hereby appropriated to the Philadelphia Health and Education Corporation, for the College of Medicine for the fiscal year July 1, 2004, to June 30, 2005, for operating expenses.
- Section 2. (a) Payments to the Philadelphia Health and Education Corporation on account of the appropriations provided in section 1(a), (b), (c) and (f) shall be made quarterly by the Secretary of Education on the basis of costs during the fiscal year and shall be conditioned on continuing authority for inclusion on the Board of Trustees of the Philadelphia Health and Education Corporation of a minimum of five persons who are not elected officials and who are appointed by the Governor, the President pro tempore of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives and the Minority Leader of the House of Representatives for terms of office coterminous with that of the respective appointing authority; and shall be further conditioned on these appointees receiving full voting rights as members of the board of trustees.
- (b) Payments to the Philadelphia Health and Education Corporation on account of the appropriations provided in section 1(d) and (e) shall be made by the Secretary of Health in equal quarterly payments.

Section 3. (a) The Philadelphia Health and Education Corporation shall provide full, complete and accurate information for the appropriations under section 1(a), (b), (c) and (f) as may be required by the Department of Education or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.

(b) The Philadelphia Health and Education Corporation shall provide full, complete and accurate information for the appropriations under section 1(d) and (e) as may be required by the Department of Health or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.

Section 4. The Philadelphia Health and Education Corporation for the Colleges of Medicine, Public Health, Nursing and Health Professions shall report its revenues and expenditures and present its financial statements in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-Related Colleges and Universities."

Section 5. The trustees of the Philadelphia Health and Education Corporation for the Colleges of Medicine, Public Health, Nursing and Health Professions shall report on forms provided by the Department of Education to both the chairman and minority chairman of the Appropriations Committee of the Senate and the chairman and minority chairman of the Appropriations Committee of the House of Representatives by September 30, 2005, on how State-appropriated funds were expended for fiscal year 2004-2005 to reduce the costs to Pennsylvania resident students or to provide services to Pennsylvania residents.

Section 6. This act shall take effect July 1, 2004, or immediately, whichever is later.
