POW/MIA MEMORIAL BRIDGE, LT. COLONEL RICHARD J. BERRETTINI MEMORIAL BRIDGE, POTTER COUNTY WORLD WAR II VETERANS MEMORIAL BRIDGE AND VETERANS MEMORIAL GAY STREET BRIDGE - DESIGNATIONS Act of Feb. 17, 2010, P.L. 134, No. 6 Cl. 87

AN ACT

Designating the bridge on US Route 6 over Potato Creek at Smethport, McKean County, as the POW/MIA Memorial Bridge; designating State Route 120 in the Borough of Emporium as General Joseph T. McNarney Memorial Boulevard; designating the bridge on US Route 6 over Allegheny River at Liberty Township, McKean County, as the Lt. Colonel Richard J. Berrettini Memorial Bridge; designating the Main Street Bridge carrying US Route 6 at Segment 260, offset 0711, over the Allegheny River in Coudersport Borough, Potter County, as the Potter County World War II Veterans Memorial Bridge; and designating the Gay Street Bridge on State Route 113, which crosses French Creek in the Borough of Phoenixville, Chester County, as the Veterans Memorial Gay Street Bridge.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. POW/MIA Memorial Bridge.

- (a) Designation.--The bridge on US Route 6 over Potato Creek in the Borough of Smethport, McKean County, beginning at Segment 0780, offset 0000, is hereby designated as the POW/MIA Memorial Bridge.
- (b) Signs.--The Department of Transportation shall erect and maintain appropriate signs at each end of the bridge displaying the name of the bridge.

 Section 2. General Joseph T. McNarney Memorial Boulevard.
- (a) Designation.--The section of State Route 120 through the Borough of Emporium, Cameron County, beginning at State Route 120, Segment 0220, offset 08882 to State Route 120, Segment 0260, offset 0585 for a total length of 7,375 feet or 1.4 miles is hereby designated as the General Joseph T. McNarney Memorial Boulevard.
- (b) Signs.--The Department of Transportation shall erect and maintain appropriate signs to indicate the designation under subsection (a) in both directions.

 Section 3. Lt. Colonel Richard J. Berrettini Memorial Bridge.
- (a) Designation. -- The bridge on US Route 6 over the Allegheny River in Liberty Township, McKean County, is hereby designated as the Lt. Colonel Richard J. Berrettini Memorial Bridge.
- (b) Signs.--The Department of Transportation shall erect and maintain appropriate signs to indicate the designation under subsection (a) in both directions.

 Section 4. Potter County World War II Veterans Memorial Bridge.
- (a) Designation. -- The Main Street Bridge carrying US Route 6 at Segment 260, offset 0711, over the Allegheny River in Coudersport Borough, Potter County, is hereby designated the Potter County World War II Veterans Memorial Bridge.
- (b) Signs.--The Department of Transportation shall erect and maintain appropriate signs to indicate the designation under subsection (a) in both directions.

 Section 5. Veterans Memorial Gay Street Bridge.
- (a) Designation. -- The Gay Street Bridge, which crosses French Creek on State Route 113 in Phoenixville Borough, Chester

County, is hereby designated as the Veterans Memorial Gay Street Bridge.

(b) Signs.--The Department of Transportation shall erect and maintain appropriate signs to indicate the designation under subsection (a) in both directions. Section 6. Effective date.

This act shall take effect in 60 days.
