## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, further providing for homicide by vehicle while
- driving under influence.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3735(a) of Title 75 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 3735. Homicide by vehicle while driving under influence.
- 9 (a) Offense defined. -- [Any person who unintentionally causes
- 10 the death of another person as the result of a violation of
- 11 section 3802 (relating to driving under influence of alcohol or
- 12 controlled substance) and who is convicted of violating section
- 13 3802 is guilty of a felony of the second degree when the
- 14 violation is the cause of death and the sentencing court shall
- 15 order the person to serve a minimum term of imprisonment of not
- 16 less than three years. A consecutive three-year term of
- 17 imprisonment shall be imposed for each victim whose death is the



1	result of the violation of section 3802.]
2	(1) Any person who unintentionally causes the death of
3	another person as the result of a violation of section 3802
4	(relating to driving under influence of alcohol or controlled
5	substance) and who is convicted of violating section 3802 if
6	the violation is the cause of death:
7	(i) is guilty of a felony of the second degree; or
8	(ii) is guilty of a felony of the first degree if,
9	before sentencing on the present violation, the person
10	has incurred a conviction, adjudication of delinquency,
11	juvenile consent decree, acceptance of accelerated
12	rehabilitative disposition or other form of preliminary
13	disposition for any of the following:
14	(A) An offense under section 3802 (a), (b),
15	(c), (d) or (f).
16	(B) An offense under former section 3731 (a)
17	(1), (2), (3) or (4)(i) (relating to driving under
18	influence of alcohol or controlled substance).
19	(C) An offense which constitutes a felony under
20	Ch. 37, Subch. B (relating to serious traffic
21	offenses).
22	(D) An offense substantially similar to an
23	offense under clause (A), (B) or (C) in another
24	jurisdiction.
25	(E) Any combination of the offenses under clause
26	(A), (B), (C) or (D).
27	(2) The sentencing court shall order a person convicted
28	under paragraph (1)(i) to serve a minimum term of
29	imprisonment of not less than three years. A consecutive
30	three-year term of imprisonment shall be imposed for each
