

## AMENDMENTS TO HOUSE BILL NO. 1009

1 Amend Bill, page 1, line 4, by striking out the period after  
2 "County" and inserting  
3 ; and authorizing the release of Project 70 restrictions on  
4 certain lands owned by Upper Uwchlan Township, Chester  
5 County, in exchange for the provision of money for the  
6 purchase and installation of recreational equipment and the  
7 implementation of a multiuse trail.

8 Amend Bill, page 3, by inserting between lines 28 and 29

9 Section 2. Restrictions in Upper Uwchlan Township, Chester  
10 County.

11 (a) Authorization.--Under the requirements of section 20(b)  
12 of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as  
13 the Project 70 Land Acquisition and Borrowing Act, the General  
14 Assembly hereby authorizes the release of Project 70  
15 restrictions on land owned by Upper Uwchlan Township, Chester  
16 County, described in subsection (b), in exchange for the  
17 provision of money for the purchase and installation of  
18 recreational equipment and the implementation of a multiuse  
19 trail as provided under subsection (c).

20 (b) Land to be released from Project 70 restrictions.--The  
21 land to be released from Project 70 restrictions is as follows:

22 ALL THAT CERTAIN tract or parcel of land located south of the  
23 Pennsylvania Turnpike (200-foot right-of-way) and east of Park  
24 Road (50-foot right-of-way), situate in the Township of Upper  
25 Uwchlan, County of Chester, Commonwealth of Pennsylvania, being  
26 a portion of the lands of Supervisors of Upper Uwchlan Township  
27 to be conveyed to the Pennsylvania Turnpike, as shown on and  
28 described in accordance with the Pennsylvania Turnpike  
29 Commission Plan No. R/W 6025-RA, prepared by Traffic Planning  
30 and Design., Inc., dated October 13, 2017, as follows:

31 Beginning at a point at the intersection of the easterly  
32 legal right-of-way line for township road T-523 (Park Road) and  
33 the southerly legal right-of-way line for limited access of the  
34 grantee, said point being located 8 feet left of and opposite T-  
35 523 construction Baseline Station 14+45±;

36 Thence along the southerly legal right-of-way line for  
37 limited access of the grantee, 49.18 feet along an arc of a

1 curve to the left having a radius of 5829.65 feet, the chord of  
2 which has a bearing of South 61°03'35" East and a length of  
3 49.18 feet to a point, said point being located 35 feet more or  
4 less right of and opposite T-523 construction Baseline at  
5 Station 14+70±;

6 Thence through lands of the grantor the following seven (7)  
7 courses,

- 8 (1) South 85°44'20" West a distance of 22.21 feet to a point  
9 being located 25 feet right of and opposite T-523  
10 construction Baseline at Station 14+50,
- 11 (2) South 61°36'48" West a distance of 102.05 feet to a  
12 point being located 25 feet right of and opposite T-523  
13 construction Baseline at Station 13+50,
- 14 (3) South 65°54'38" West a distance of 81.65 feet to a point  
15 being located 25 feet right of and opposite T-523  
16 construction Baseline at Station 12+70,
- 17 (4) South 22°10'47" East a distance of 15.00 feet to a point  
18 being located 40 feet right of and opposite T-523  
19 construction Baseline at Station 12+70,
- 20 (5) South 68°30'46" West a distance of 29.97 feet to a point  
21 being located 40 feet right of and opposite T-523  
22 construction Baseline at Station 12+41,
- 23 (6) South 69°12'19" West a distance of 241.00 feet to a  
24 point being located 40 feet right of and opposite T-523  
25 construction Baseline at Station 10+00, and
- 26 (7) North 20°47'41" West a distance of 18.34 feet to a point  
27 being located 22 feet more or less right of and opposite  
28 T-523 construction Baseline at Station 10+00,

29 Thence along the easterly legal right-of-way line for  
30 township road T-428 the following three (3) courses,

- 31 (1) North 68°55'50" East a distance of 60.69 feet to a point  
32 being located 21 feet more or less right of and opposite  
33 T-523 construction Baseline at Station 10+61±,
- 34 (2) 261.80 feet along an arc of a curve to the right having  
35 a radius of 1500.00 feet, the chord of which has a  
36 bearing of North 63°55'50" West and a length of 261.47  
37 feet to a point, said point being located 0 feet more or  
38 less right of and opposite T-523 construction Baseline  
39 Station 13+21±, and
- 40 (3) North 58°55'50" East a distance of 123.72 feet to the  
41 Point of Beginning.

42 Containing 0.259 acre. Includes 0.025 acre of R/W reserved by  
43 Columbia Gas Corp.

44 Subject to all covenants and agreements of record.

45 A portion of Chester County Tax Map Parcel 32-3-80-E, 32-3-77.5-  
46 E, and 32-3-77.10-E.

47 (c) Duties.--The Pennsylvania Turnpike Commission shall do  
48 all of the following:

- 49 (1) Provide money to Upper Uwchlan Township, Chester  
50 County, for the purchase and installation of recreational  
51 equipment to be used at a park located on the land described

1 under subsection (b).  
2 (2) Implement a multiuse trail on a bridge which will  
3 permit pedestrian access to a park located on the land  
4 described under subsection (b).
