20 (6) An institution of higher education located in and  
21 incorporated or chartered by the Commonwealth and entitled to  
22 confer degrees as set forth in section 6505 (relating to  
23 power to confer degrees) and as provided for by the standards  
24 and qualifications prescribed by the State Board of Education  
25 under Chapter 65 (relating to private colleges, universities  
26 and seminaries).

27 (7) A private school licensed under the act of December  
28 15, 1986 (P.L.1585, No.174), known as the Private Licensed  
29 Schools Act.

30 (8) A foreign corporation approved to operate an  
31 educational enterprise under 22 Pa. Code Ch. 36 (relating to  
32 foreign corporation standards).

(d) Review and update.--If an institution of higher  
education adopts a plan under subsection (a), the institution of  
higher education shall review and update the plan at least once  
annually.

§ 7104. Certified suicide prevention institution of higher  
education.

(a) Transmittal of plan.--If an institution of higher  
education adopts a plan under section 7103(a) (relating to  
student mental health and suicide prevention plans), the  
institution of higher education shall transmit a copy of the  
plan to the Department of Education by August 1 of each year.

(b) Duties of department.--

(1) If the Department of Education receives a student  
mental health and suicide prevention plan from an institution  
of higher education, the department shall post that  
information on its publicly accessible Internet website.

(2) If an institution of higher education submits a plan  
to the Department of Education containing information under  
section 7103(a) (1), (2), (3), (4), (5) and (6), the

1 department shall designate the institution of higher  
2 education as a certified suicide prevention institution of  
3 higher education.

4 (3) The Department of Education may adopt or create a  
5 logo for institutions of higher education that have been  
6 certified as certified suicide prevention institutions of  
7 higher education. If the Department of Education adopts or  
8 creates a logo, an institution of higher education which has  
9 been certified by the Department of Education may use the  
10 logo.

11 (c) Designation of institution of higher education.--Upon  
12 listing of an institution of higher education's plan containing  
13 information under section 7103(a) (1), (2), (3), (4), (5) and (6)  
14 on the Department of Education's publicly accessible Internet  
15 website, the institution of higher education may use and market  
16 the designation of "Certified Suicide Prevention Institution of  
17 Higher Education."
