10 supplements under 24 Pa.C.S. § 8348 (relating to supplemental
11 annuities) and 71 Pa.C.S. § 5708 (relating to supplemental
12 annuities).

13 (4) The Pennsylvania Public Television Network
14 Commission.

15 (5) The Public Television Broadcasting Advisory Council.

16 (6) The Pennsylvania Quality Leadership Awards Council.

17 (7) The Small Business Advocacy Council within the
18 Department of Community and Economic Development.

19 (8) The Tobacco Use Prevention and Cessation Advisory
20 Committee within the Department of Health.

21 Section 2. Repeals.

22 Repeals are as follows:

23 (1) The General Assembly declares that the repeals under
24 paragraph (2) are necessary to effectuate the provisions of
25 this act.

26 (2) The following acts and parts of acts are repealed:

27 (i) As much as reads "the Pennsylvania Public
28 Television Network Commission," in section 207.1(d)(4) of
29 the act of April 9, 1929 (P.L.177, No.175), known as The
30 Administrative Code of 1929.

31 (ii) The last sentence of section 523 of the act of
32 March 10, 1949 (P.L.30, No.14), known as the Public
33 School Code of 1949.

34 (iii) The act of November 20, 1968 (P.L.1075,
35 No.329), referred to as the Public Television Network
36 System Law.

37 (iv) Section 3 of the act of December 18, 1979

1 (P.L.566, No.130), entitled "An act amending Titles 24
2 (Education) and 71 (State Government) of the Pennsylvania
3 Consolidated Statutes, further providing for a cost-of-
4 living increase to annuitants."

5 (v) The act of November 24, 1992 (P.L.732, No.111),
6 known as the Pennsylvania Quality Improvement Act.

7 (vi) Chapter 7 of the act of June 27, 1996 (P.L.403,
8 No.58), known as the Community and Economic Development
9 Enhancement Act.

10 (vii) The definition of "advisory board" in section
11 2 and sections 9 and 10 of the act of June 22, 2001
12 (P.L.400, No.31), known as the Industrial Resources
13 Center Partnership Act.

14 (viii) The following provisions of the act of June
15 26, 2001 (P.L.755, No.77), known as the Tobacco
16 Settlement Act:

18 702.

19 (B) As much as reads "in consultation with the
20 committee" in section 704(2).
