20 (2) The task force shall consult other Commonwealth agencies  
21 as appropriate, including, but not limited to, the Department of  
22 General Services, the Department of Environmental Protection,  
23 the Department of Community and Economic Development and the  
24 Office of Budget. If the task force, through its chairperson,  
25 requests the cooperation of an agency, the agency shall make  
26 reasonable efforts to assist the task force in the performance  
27 of its duties.

28 (g) For the purposes of this section, the term "employee  
29 misclassification" shall mean the classification of an employee  
30 as an independent contractor in violation of any law of this  
31 Commonwealth, including, but not limited to:

32 (1) The act of October 13, 2010 (P.L.506, No.72), known as  
33 the "Construction Workplace Misclassification Act."

34 (2) The act of June 2, 1915 (P.L.736, No.338), known as the  
35 "Workers' Compensation Act."

36 (3) The act of December 5, 1936 (2nd Sp.Sess., 1937  
37 P.L.2897, No.1), known as the "Unemployment Compensation Law."

38 (4) The act of March 4, 1971 (P.L.6, No.2), known as the  
39 "Tax Reform Code of 1971."

40 (h) This section shall not be construed to require any  
41 Commonwealth agency to provide a member of the task force, who  
42 is not employed by the Commonwealth agency, with any information

1 that would not be available to a member of the public under the  
2 act of February 14, 2008 (P.L.6, No.3), known as the "Right-to-  
3 Know Law."  
4 (i) This section shall expire two years after the effective  
5 date of this subsection.
