39 PART I  
40 GENERAL PROVISIONS

41 Section 101. Short title.

42 This act shall be known and may be cited as the General  
43 Appropriation Act of 2020.

44 Section 101.1. Intent.

45 It is the intent of this general appropriation act to provide  
46 interim funding for the fiscal year July 1, 2020, to June 30,  
47 2021, to minimize disruptions to services and programs in this  
48 Commonwealth.

1 Section 102. Definitions.

2 The following words and phrases when used in this act shall  
3 have the meanings given to them in this section unless the  
4 context clearly indicates otherwise:

5 "Current fiscal year." The fiscal year beginning July 1,  
6 2020, and ending June 30, 2021.

7 "Employees." Includes all directors, superintendents, bureau  
8 or division chiefs, assistant directors, assistant  
9 superintendents, assistant chiefs, experts, scientists,  
10 engineers, surveyors, draftsmen, accountants, secretaries,  
11 auditors, inspectors, examiners, analysts, statisticians,  
12 marshals, clerks, stenographers, bookkeepers, messengers and  
13 other assistants in a department, board or commission.

14 "Expenses" and "maintenance." Includes all printing, binding  
15 and stationery, food and forage, materials and supplies,  
16 traveling expenses, training, motor vehicle supplies and  
17 repairs, freight, express and cartage, postage,  
18 telecommunication devices and telecommunication rentals and toll  
19 charges, newspaper advertising and notices, public advertising  
20 by or through any medium, fuel, light, heat, power and water,  
21 minor construction and renovation, repairs or reconstruction of  
22 equipment, buildings and facilities, rent of real estate and  
23 equipment, premiums on workers' compensation, insurance premiums  
24 on policies of liability insurance, insurance premiums on  
25 medical payment insurance and surety bonds for volunteer  
26 workers, premiums on employee group life insurance and employee  
27 and retired employee group hospital and medical insurance,  
28 payment of Commonwealth share of Social Security taxes and  
29 unemployment compensation costs for State employees, the  
30 purchase of replacement or additional equipment and machinery  
31 and all other incidental costs and expenses, including payment  
32 to the Department of General Services of mileage and other  
33 charges for the use of motor vehicles and rental payments for  
34 permanently assigned motor vehicles and of expenses or costs of  
35 services incurred through the Purchasing Fund. The term  
36 "expenses" also shall include the medical costs for the  
37 treatment of inmates of State institutions when the inmate must  
38 be transferred to an outside hospital, provided that in no case  
39 shall the State institution pay more for patient care than that  
40 provided under the State medical assistance program.

41 "Prior fiscal year." The fiscal year beginning July 1 of the  
42 fiscal year immediately prior to the current fiscal year.

 48 Section 104. State appropriations.  
 49 (a) General Fund.--Except as provided in Part LI, the sums  
 50 specified in this act, or as much thereof as may be necessary,  
 51 are specifically appropriated from the General Fund to agencies

1 of the Executive, Legislative and Judicial Departments of the  
2 Commonwealth for the payment of salaries, wages or other  
3 compensation and travel expenses of the duly elected or  
4 appointed officers and employees of the Commonwealth, for the  
5 payment of fees for contractual services rendered, for the  
6 purchase or rental of goods and services, printing, public  
7 advertising by or through any medium, equipment, land and  
8 buildings and for payment of any other expenses, as provided by  
9 law or by this act, necessary for the proper conduct of the  
10 duties, functions and activities and for the purposes specified  
11 in this act for the current fiscal year and for the payment of  
12 bills incurred and remaining unpaid at the close of the prior  
13 fiscal year.

14 (b) Special funds and accounts.--Except as provided in Part  
15 LI, the sums specified in this act, or as much thereof as may be  
16 necessary, are specifically appropriated from the special funds  
17 and accounts in the State Treasury to agencies of the Executive  
18 and Judicial Departments of the Commonwealth for the payment of  
19 salaries, wages or other compensation and travel expenses of the  
20 duly appointed officers and employees of the Commonwealth, for  
21 the payment of fees for contractual services rendered, for the  
22 purchase or rental of goods and services and for payment of any  
23 other expenses, as provided by law or by this act, necessary for  
24 the proper conduct of the duties, functions and activities and  
25 for the purposes specified in this act for the current fiscal  
26 year and for the payment of bills incurred and remaining unpaid  
27 at the close of the prior fiscal year.

28 Section 105. Federal appropriations.

29 Except as otherwise provided in section 5102, the Federal  
30 appropriations specified in this act, or as much thereof as may  
31 be necessary, are specifically appropriated to the agencies of  
32 the Executive Department of the Commonwealth specified in this  
33 act for the payment of the expenses of implementing and carrying  
34 out the programs specified in this act for the current fiscal  
35 year and for the payment of bills incurred and remaining unpaid  
36 at the close of the prior fiscal year. Unless otherwise stated,  
37 the Federal appropriations include any carryovers from the prior  
38 fiscal year.

Section 5102. Federal appropriations.
