19 candidate for election to public office shall file with the
20 appropriate supervisor reports of receipts and expenditures on
21 forms, designed by the Secretary of the Commonwealth, if the

23 the sum of two hundred fifty dollars (\$250). Should such an
24 amount not exceed two hundred fifty dollars (\$250), then the
25 candidate or the treasurer of the committee shall file a [sworn]
26 statement to that effect with the appropriate supervisor rather
27 than the report required by this section.

29 (h) All reports or statements required to be filed pursuant
30 to this section shall be filed pursuant to [section 1630]
31 sections 1629 and 1631.1. All reports and statements required by

1 this section shall cover the campaign activity of a candidate
2 only from the last prior report or statement.

22 [(a) Each report shall be subscribed and sworn to by the
23 individual submitting the report. In addition, any report filed
24 by a political committee, authorized by a candidate and created
25 solely for the purpose of influencing an election on behalf of
26 that candidate, must be accompanied by an affidavit from that
27 candidate which provides that, to the best of the candidate's
28 knowledge, the political committee has not violated any
29 provision of this act.]

30 (b) Any wilfully false, fraudulent or misleading statement
31 or entry made by any candidate or treasurer in any statement or
32 report [under oath] as required by this article, shall
33 constitute the crime of [perjury] unsworn falsification to
34 authorities, and be punishable as such according to the laws of
35 this Commonwealth.

2 Section 1641. Reports by Business Entities; Publication by
3 Secretary of the Commonwealth.--

4 (a) Any business entity including but not limited to a
5 corporation, company, association, partnership or sole
6 proprietorship, which has been awarded non-bid contracts from
7 the Commonwealth or its political subdivisions during the
8 preceding calendar year, shall report electronically in
9 accordance with section 1631.1 by February 15 of each year to
10 the Secretary of the Commonwealth an itemized list of all
11 political contributions known to the business entity by virtue
12 of the knowledge possessed by every officer, director,
13 associate, partner, limited partner or individual owner that has
14 been made by:

15 (1) any officer, director, associate, partner, limited
16 partner, individual owner or members of their immediate family
17 when the contributions exceed an aggregate of one thousand
18 dollars (\$1,000) by any individual during the preceding year; or

19 (2) any employe or members of his immediate family whose
20 political contribution exceeded one thousand dollars (\$1,000)
21 during the preceding year.

22 For the purposes of this subsection, "immediate family" means a
23 person's spouse and any unemancipated child.
