22 Program established under section 10502.1 (relating to
23 establishment of program).

24 "Rural municipality." A municipality of this Commonwealth
25 with a population density less than the Statewide average
26 population density or a total population less than 2,500, unless
27 more than 50% of the population lives in an urbanized area, as
28 defined by the United States Census Bureau.

29 "Silvicultural product." A product of a forest or woodland,
30 including, but not limited to, timber.

31 "Specialty crop." A horticultural crop or silvicultural
32 product, a plant cultivated and utilized for fiber or biofuel
33 purposes or an apiary product.

34 "Urban municipality." A municipality of this Commonwealth
35 not defined as a rural municipality.
