19 Section 2. Sections 4(a) and 5 of the act are amended to  
20 read:

21 Section 4. Repair obligations.

22 (a) Repairs required.--The manufacturer of a new motor  
23 vehicle sold or leased and registered in the Commonwealth shall  
24 repair or correct, at no cost to the purchaser, a nonconformity  
25 which substantially impairs the use, value or safety of said  
26 motor vehicle which:

27 (1) in the case of a motorcycle, may occur within a  
28 period of one year following the actual delivery of the  
29 motorcycle to the purchaser or during the term of the

1 warranty, whichever may occur first; or  
2 (2) in the case of any other new motor vehicle, may  
3 occur within a period of one year following the actual  
4 delivery of the vehicle to the purchaser, within the first  
5 12,000 miles of use or during the term of the warranty,  
6 whichever may first occur.

8 Amend Bill, page 3, lines 9 through 11, by striking out all  
9 of said lines and inserting

10 Section 3. Section 6(a) and (b) of the act are amended by  
11 adding paragraphs and the section is amended by adding a  
12 subsection to read:

13 Amend Bill, page 3, line 13, by striking out all of said line  
14 and inserting

15 (a) General rule.--It shall be presumed that a reasonable  
16 number of attempts have been undertaken to repair or correct a  
17 nonconformity if:

19 (3) For a motorcycle, manufacturer-sourced parts have  
20 been used in the attempts to repair the nonconformity.

21 Amend Bill, page 4, line 4, by inserting after

22 "nonconformity."

23 The manufacturer's authorized service and repair facility  
24 that performed the repairs shall provide an affidavit that the  
25 nonconformity has been subject to repair three times.
