

## AMENDMENTS TO SENATE BILL NO. 845

7 Section 2. Chapter 90 of Title 75 is amended by adding a  
8 subchapter heading to read:

11 Section 3. Section 9002 of Title 75 is amended by adding  
12 definitions to read:

13 § 9002. Definitions.

14 The following words and phrases when used in this chapter  
15 shall have the meanings given to them in this section unless the  
16 context clearly indicates otherwise:

18 "Electric vehicle." The term includes electric vehicles and  
19 hybrid electric vehicles. The term does not include qualified  
20 motor vehicles as defined under section 2101.1 (relating to  
21 definitions).

22 "Electric vehicle road use fee." The annual fee imposed  
23 under Subchapter C (relating to electric vehicle road use fee)  
24 in place of a tax on alternative fuels assessed upon electricity  
25 used in electric vehicles.

26 "Exempt entity." A person exempt under section 9004(e)  
27 (relating to imposition of tax, exemptions and deductions) from  
28 reporting and paying a tax on liquid fuels, fuels or alternative  
29 fuels imposed by this chapter.

8 § 9031. Short title of subchapter.

9 This subchapter shall be known and may be cited as the  
10 Electric Vehicle Road Use Fee Act.

11 § 9032. Road use fee imposed on electric vehicles.

12 (a) Fee required for registration.--Concurrent with  
13 submitting an annual or biennial vehicle registration  
14 application and fee to the Department of Transportation under  
15 section 1301 (relating to registration and certificate of title  
16 required), an owner of an electric vehicle shall submit the  
17 electric vehicle road use fee. The following shall apply:

18 (1) Registration may not be considered complete without  
19 payment in full of the electric vehicle road use fee.

20 (2) The electric vehicle road use fee shall be paid upon  
21 initial registration and upon renewal for each electric  
22 vehicle registered in this Commonwealth.

23 (b) Computation of electric vehicle road use fee.--

24 (1) The electric vehicle road use fee for any electric  
25 motorcycle and neighborhood electric vehicle shall be \$15 per  
26 year.

27 (2) The electric vehicle road use fee for any hybrid  
28 electric vehicle with a gross vehicle weight rating of not  
29 more than 26,000, but not a motorcycle shall be \$75 per year.

30 (3) The electric vehicle road use fee for any electric  
31 vehicle with a gross vehicle weight rating of not more than  
32 26,000, but not a motorcycle shall be \$175 per year. For  
33 purposes of this subparagraph, an electric vehicle shall not  
34 include a hybrid electric vehicle.

35 (4) The electric vehicle road use fee for any electric  
36 vehicle with a gross vehicle weight rating of 26,001 or more  
37 shall be \$250 per year.

38 § 9033. Electricity used in electric vehicles.

39 Electricity used in an electric vehicle that propels a  
40 vehicle on public highways is not considered a liquid fuel, fuel  
41 or alternative fuel as defined under this chapter.

42 § 9034. Fees for highway maintenance and construction.

43 Fees collected under this subchapter shall be deposited in  
44 the Motor License Fund in accordance with the allocations under  
45 section 9511 (relating to allocation of proceeds). For purposes  
46 of aligning the electric vehicle road use fee with the  
47 allocations of proceeds, the electric vehicle road use fee must  
48 be allocated in accordance with the oil company franchise tax  
49 for highway maintenance and construction under section 9502  
50 (relating to imposition of tax).

51 § 9035. Exempt entities.

1     (a) Exemption.--An electric vehicle registered to an exempt  
2 entity under section 9004(e) (relating to imposition of tax,  
3 exemptions and deductions) is exempt from paying the electric  
4 vehicle road use fee.

5     (b) Requirements.--The following apply:

6         (1) If an electric vehicle registered to an exempt  
7 entity is used for a nonexempt purpose during the  
8 registration year, the exempt entity shall pay an  
9 administrative penalty of \$500 to the department. An exempt  
10 entity that improperly uses a vehicle for nonexempt purposes  
11 is not eligible to claim a refund for the vehicle under the  
12 provisions of section 9036 (relating to refunds).

13         (2) An exempt entity applying for a refund under section  
14 9036 shall maintain records of vehicle usage, certifying that  
15 an individual trip made by the vehicle was for a qualified  
16 exempt use. Individual trip logs, odometer readings and  
17 driver signatures shall be among the records required to  
18 substantiate exempt use.

19         (3) The department may inspect the substantiating  
20 records for an exempt entity at any time.

21         (4) The exempt entity shall cooperate with an agent of  
22 the department in an inspection.

23         (5) An exempt entity that refuses to permit the  
24 department or an agent appointed by the department in writing  
25 to examine the books, records, papers or other equipment  
26 associated with the operation of an electric vehicle commits  
27 a summary offense and shall pay a fine of \$500 for each  
28 electric vehicle owned or operated by the exempt entity.

29 § 9036. Refunds.

30     A person may be entitled to a refund of the electric vehicle  
31 road use fee paid for a vehicle that would otherwise have been  
32 exempt under section 9004 (relating to imposition of tax,  
33 exemptions and deductions). A person entitled to a refund of the  
34 electric vehicle road use fee shall apply for an annual refund  
35 in a manner similar to the refund process used for liquid fuels,  
36 fuels and alternative fuels under section 9017 (relating to  
37 refunds).

38 § 9037. Regulations.

39     The department, in coordination with the Department of  
40 Transportation, may promulgate regulations to implement the  
41 addition of this subchapter.
