

## AMENDMENTS TO SENATE BILL NO. 890

1 Amend Bill, page 1, lines 20 through 22, by striking out all  
2 of said lines and inserting

3 Section 1. The definitions of "worker with a disability" and  
4 "worker with a medically improved disability" in section 1502 of  
5 the act of June 26, 2001 (P.L.755, No.77), known as the Tobacco  
6 Settlement Act, are amended and the section is amended by adding  
7 a definition to read:

8 Amend Bill, page 2, by inserting between lines 3 and 4

9 "Worker with a disability." An individual who meets all of  
10 the following:

11 (1) is at least 16 years of age [but less than 65 years  
12 of age] and meets age requirements as established under  
13 applicable Federal law;

14 (2) is employed and receiving compensation;

15 (3) is eligible to receive Supplemental Security Income  
16 except for earnings and resources that exceed the limit  
17 established in section 1905 of the Social Security Act (49  
18 Stat. 620, 42 U.S.C. § 1396d(q)(2)(B));

19 (4) has monthly income below 250% of the Federal poverty  
20 income guidelines; and

21 (5) has countable resources equal to or less than  
22 \$10,000.

23 "Worker with a medically improved disability." An individual  
24 who meets all of the following:

25 (1) is at least 16 years of age [but less than 65 years  
26 of age] and meets age requirements as established under  
27 applicable Federal law;

28 (2) is employed at least 40 hours per month and is  
29 earning at least the applicable minimum wage under section 6  
30 of the Fair Labor Standards Act of 1938 (52 Stat. 1060, 29  
31 U.S.C. § 206);

32 (3) was previously a worker with a disability and  
33 participated in medical assistance;

34 (4) has monthly income below 250% of the Federal poverty  
35 income guidelines; and

36 (5) has countable resources equal to or less than  
37 \$10,000.

1 Amend Bill, page 2, lines 6 and 7, by striking out "but less  
2 than 65 years" in line 6 and all of line 7 and inserting  
3 and meets age requirements as established under Federal  
4 law;

5 Amend Bill, page 2, lines 11 through 18, by striking out all  
6 of said lines and inserting

7 (3) has participated in a medical assistance for workers  
8 with disabilities category or a medical assistance for  
9 workers with medically improved disabilities category for the  
10 previous 12 consecutive months;

11 (4) has monthly income that is more than 250% of the  
12 Federal poverty income guidelines and less than 600% of the  
13 Federal poverty income guidelines; and

14 Amend Bill, page 4, line 9, by inserting after "success"  
15 who participates in medical assistance for workers with  
16 disabilities

17 Amend Bill, page 4, lines 16 through 20, by striking out "The  
18 income and assets" in line 16, all of lines 17 through 19 and  
19 "assistance benefits." in line 20

20 Amend Bill, page 4, line 21, by inserting after "enrollee"  
21 who was

23 the worker's participation in the medical assistance for workers  
24 with disabilities program"

25 Amend Bill, page 4, line 25, by striking out "under" and  
26 inserting
