5 FROM THE DATE OF TRANSFER OF OWNERSHIP TO THE TAXPAYER" and

14 (A) a copy of the deed showing the date of real property
15 transfer; or

16 (B) a copy of the title following the acquisition of a
17 mobile or manufactured home subject to taxation as real estate
18 showing the date of issuance or a copy of an executed lease
19 agreement between the owner of a mobile or manufactured home and
20 the owner of a parcel of land on which the mobile or
21 manufactured home will be situated showing the date the lease
22 commences; and

8 (4) A tax collector that accepts a waiver and payment in
9 good faith in accordance with this subsection shall not be
10 personally liable for any amount due or arising from the real
11 estate tax that is the subject in the waiver.

15 Amend Bill, page 3, by inserting between lines 11 and 12
16 The term "qualifying event" shall mean:
17 (i) For purposes of real property, the date of transfer of
18 ownership.
19 (ii) For purposes of manufactured or mobile homes, the date
20 of transfer of ownership or the date a lease agreement commences
21 for the original location or relocation of a mobile or
22 manufactured home on a parcel of land not owned by the owner of
23 the mobile or manufactured home. The term does not include the
24 renewal of a lease for the same location.

29 Amend Bill, page 3, lines 19 and 20, by striking out all of

31 secure collection of, or take any action at law or in equity
32 against, the person or property of the taxpayer for the real
33 estate tax or amounts, liens or claims derived from the real
34 estate tax.
