17 "High-risk missing person." An individual who is 18 years of  
18 age or older and:

19 (1) whose temporary or permanent residence is in this  
20 Commonwealth or is believed to be in this Commonwealth;

21 (2) whose whereabouts are unknown;

22 (3) who has been reported missing to a law enforcement  
23 agency; and

24 (4) circumstances indicate any of the following:

25 (i) the individual is missing as a result of a  
26 stranger abduction;

27 (ii) the individual is missing under suspicious,  
28 unknown or dangerous circumstances and the law  
29 enforcement agency reasonably believes that the  
30 individual is at risk of injury or death;

1           (iii) the individual is missing for more than 30  
2           days; or  
3           (iv) the individual has been designated as a high-  
4           risk missing person by another law enforcement agency.

8           missing persons and missing children.

9           (a) Collection of DNA samples.--In an investigation of a  
10          high-risk missing person or missing child, the law enforcement  
11          agency shall immediately collect a DNA sample from available  
12          personal articles belonging to the missing person or missing  
13          child for law enforcement identification purposes.

14          (b) Submission of DNA samples.--Within 48 hours of the  
15          collection under subsection (a), the DNA sample shall be  
16          delivered to the Pennsylvania State Police for forensic DNA  
17          analysis as provided in section 2318 (relating to procedures for  
18          conduct, disposition and use of DNA analysis) and submission to  
19          the National Missing and Unidentified Persons System as provided  
20          in section 2319 (relating to DNA data base exchange), along with  
21          the following information, if known to the investigating law  
22          enforcement agency:

23           (1) The name of the high-risk missing person or missing  
24           child.

25           (2) The age of the high-risk missing person or missing  
26           child.

27           (3) The sex of the high-risk missing person or missing  
28           child.

29           (4) The height and weight of the high-risk missing  
30           person or missing child.

31           (5) The race of the high-risk missing person or missing  
32           child.

33           (6) The last known location of the high-risk missing  
34           person or missing child.

35           (7) The date of last known contact with the high-risk  
36           missing person or missing child.

37           (8) The circumstances of the disappearance of the high-  
38           risk missing person or missing child.

39           (c) Definition.--As used in this section, the term "child"  
40           means an individual under 18 years of age.
