22 organization that requires passing a national certifying
23 examination in nurse anesthesia.

24 (2) Submit a renewal application to the Board and the
25 required fee as established by the Board.

26 (3) In the two years prior to the certification renewal,
27 complete at least thirty (30) hours of continuing education
28 approved by the Board, as required under section 12.1 of this
29 act.

30 (4) Comply with all other requirements of the Board.

35 Section 8.9. Scope of Practice for Certified Registered
36 Nurse Anesthetists.--(a) A certified registered nurse
37 anesthetist shall have the authority to perform anesthesia
38 services in cooperation with a physician, podiatrist or dentist
39 involved in a procedure for which anesthesia care is being

1 provided if the anesthesia services are performed under the
2 overall direction of any of the following:

3 (1) A physician licensed by the State Board of Medicine or
4 the State Board of Osteopathic Medicine who has completed an
5 accredited residency training program in anesthesiology.

6 (2) A physician licensed by the State Board of Medicine or
7 the State Board of Osteopathic Medicine who is performing the
8 procedure for which the certified registered nurse anesthetist
9 is performing anesthesia services.

10 (3) A podiatrist licensed by the State Board of Podiatry who
11 is performing the procedure for which the certified registered
12 nurse anesthetist is performing anesthesia services.

13 (4) A dentist licensed by the State Board of Dentistry and
14 permitted by the act of May 1, 1933 (P.L.216, No.76), known as
15 "The Dental Law" or the State Board of Dentistry to administer,
16 supervise or direct the administration of anesthesia.

17 (b) Nothing in this section shall be construed to:

18 (1) prohibit a certified registered nurse anesthetist who
19 would otherwise require direction from providing brief periods
20 of care in the event of an emergency that temporarily prevents
21 or interferes with overall direction;

22 (2) restrict the authority of a health care facility to
23 provide for additional oversight requirements for a certified
24 registered nurse anesthetist practicing within the facility; or

25 (3) limit or prohibit a certified registered nurse
26 anesthetist from engaging in those activities which normally
27 constitute the practice of nursing as defined in section 2.
