1 Amend Bill, page 1, line 2, by inserting after "Statutes,"

5 Section 1. The definition of "hybrid electric vehicle" in  
6 section 102 of Title 75 of the Pennsylvania Consolidated  
7 Statutes is amended to read:

8 § 102. Definitions.

9 Subject to additional definitions contained in subsequent  
10 provisions of this title which are applicable to specific  
11 provisions of this title, the following words and phrases when  
12 used in this title shall have, unless the context clearly  
13 indicates otherwise, the meanings given to them in this section:

15 "Hybrid electric vehicle." [An electric vehicle which allows  
16 power to be delivered to the drive wheels solely by a battery-  
17 powered electric motor but which also incorporates the use of a  
18 combustion engine to provide power to the battery and which  
19 meets the applicable Federal motor vehicle safety standards. The  
20 primary source of power for the motor must be the electric  
21 battery or battery pack and not the combustion engine.] An  
22 electric vehicle with the ability to charge an onboard battery  
23 or battery pack using an external power source which allows  
24 power to be delivered to the drive wheels solely by a battery-  
25 powered electric motor but which also incorporates the use of a  
26 combustion engine to provide power to the battery and which  
27 meets the applicable Federal motor vehicle safety standards. The  
28 primary source of power for the motor must be the electric  
29 battery or battery pack and not the combustion engine.

(a) Promulgation.--

Amend Bill, page 5, by inserting between lines 21 and 22

(b) Temporary regulations.--In order to facilitate the prompt implementation of this subchapter, regulations promulgated by the department under this section during the two years following the effective date of this section shall be deemed temporary regulations, which shall expire no later than three years following the effective date of this section or upon promulgation of final regulations. The temporary regulations may not be subject to:

(1) Sections 201, 202, 203, 204 and 205 of the act of July 31, 1968 (P.L.769, No.240), referred to as the Commonwealth Documents Law.

(2) The act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act.

(3) Section 204(b) of the act of October 15, 1980 (P.L.950, No.164), known as the Commonwealth Attorneys Act.
