11 cost principles, and audit requirements for Federal awards).

12 (2) School entity reporting to the department on the program
13 of accelerated learning shall be pursuant to Federal law, ARP
14 ESSER guidance and data elements encompassed in a school
15 entity's application to the department for ARP ESSER funding.

16 (3) The department shall compile the information required to
17 be reported under paragraph (2) and publish the information on
18 the department's publicly accessible Internet website on a
19 searchable format. The department shall update the information
20 in the database at least quarterly. The department shall submit
21 the compiled and updated information to the Education Committee
22 of the Senate and the Education Committee of the House of
23 Representatives.

5 respond to students' academic, social and emotional needs and
6 address the disproportionate impact of the coronavirus on the
7 student subgroups described in section 1111(b)(2)(B)(xi) of the
8 Elementary and Secondary Education Act of 1965 (Public Law 89-
9 10, 20 U.S.C. § 6301 et seq.), students experiencing
10 homelessness and youth in foster care.
