5 (b) Suspension and disbarment.--The following shall apply:

6 (1) If a district attorney is disbarred, the office of
7 the district attorney shall be vacant and shall be filled as
8 follows:

9 (i) Except for a county of the first or second
10 class, as provided under section 14304 (relating to
11 filling of vacancies).

12 (ii) For a county of the second class, as provided
13 under section 1404 of the act of July 28, 1953 (P.L.723,
14 No.230), known as the Second Class County Code.

15 (iii) For a county of the first class, as provided
16 under section 3 of the act of May 3, 1850 (P.L.654,
17 No.385), entitled "An act providing for the election of
18 district attorneys."

19 (2) Notwithstanding any other law applicable to a class
20 of county to the contrary, if a district attorney's law
21 license is suspended, the office of district attorney shall
22 not be vacant but the district attorney shall be suspended
23 from the office until the law license of the district
24 attorney is reinstated or the expiration of the term of the
25 district attorney, whichever is sooner. The first assistant
26 district attorney, if willing, qualified and able, shall act
27 as the district attorney during the time period that the
28 district attorney's law license is suspended. If the first
29 assistant district attorney is unwilling, unqualified or
30 unable to serve, the judges of the court of common pleas
31 shall appoint a competent person who satisfies the
32 requirements of this section to act as district attorney.
