22 including the ability to:

24 (ii) abstract perceptions made under paragraph (1)
25 into models through analysis in an automated manner; and

26 (iii) use model inference to formulate options for
27 information or action based on outcomes under

1 subparagraphs (i) and (ii).

2 (2) The term includes generative artificial
3 intelligence.
