AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 2 "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 3 4 primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 7 8 revising and consolidating the laws relating thereto; and 9 10 repealing certain acts and parts of acts relating to elections, providing for nonbinding advisory questions. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. The act of June 3, 1937 (P.L.1333, No.320), known 15 as the Pennsylvania Election Code, is amended by adding a 16 section to read: Section 302.1. Nonbinding Advisory Questions. -- A county 17 18 board of elections may cause a nonbinding advisory question to 19 be placed on the ballot whenever the governing body of a

municipality or school district, which proposes to make an

- 1 expenditure the total cost of which is equal to or greater than
- 2 <u>an amount equal to ten (10) per centum of the municipality's or</u>
- 3 school district's operating budget for the immediately preceding
- 4 <u>fiscal year, adopts, by majority vote, a resolution asking the</u>
- 5 county board to place on the ballot a question to determine the
- 6 will of the electorate of the municipality or school district
- 7 with respect to said expenditure. The governing body of the
- 8 municipality or school district shall file a copy of the
- 9 resolution with the county board. Any such question placed on
- 10 the ballot shall be submitted to the electorate at the next
- 11 general, municipal or primary election occurring more than
- 12 thirty days after the date of the filing of the resolution.
- 13 Section 2. This act shall take effect in 60 days.
