## AN ACT

- 1 Amending the act of June 23, 1931 (P.L.932, No.317), entitled
- 2 "An act relating to cities of the third class; and amending,
- 3 revising, and consolidating the law relating thereto,"
- 4 granting the mayor the authority to determine whether or not
- 5 security should accompany bids submitted in response to
- 6 advertisement.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1901(f) of the act of June 23, 1931
- 10 (P.L.932, No.317), known as The Third Class City Code, reenacted
- 11 and amended June 28, 1951 (P.L.662, No.164) and amended
- 12 September 17, 1959 (P.L.906, No.359), is amended to read:
- 13 Section 1901. Power to Make Contracts; Regulations
- 14 Concerning Contracts.--\* \* \*
- 15 (f) [All bids advertised for shall be accompanied by cash,
- 16 by a certified or cashier's good faith check in an amount
- 17 required by council but at least ten per centum of the bid, or
- 18 by a bond with corporate surety in such amount as council shall

- 1 determine but not less than ten per centum of the amount bid.]
- 2 The mayor or his designee COUNCIL may require that any bids so <---
- 3 <u>advertised be accompanied by cash, by a certified or cashier's</u>
- 4 good faith check OR OTHER IRREVOCABLE LETTER OF CREDIT in an <-
- 5 <u>acceptable amount, or by a bond with corporate surety in an</u>
- 6 acceptable amount. Whenever it is required that a bid be
- 7 <u>accompanied by cash, certified check or, cashier's good faith</u> <--
- 8 <u>check OR OTHER IRREVOCABLE LETTER OF CREDIT, no bid shall be</u>
- 9 <u>considered unless so accompanied.</u> In the event any bidder shall,
- 10 upon award of the contract to him, fail to comply with the
- 11 requirements hereinafter stated as to a bond guaranteeing the
- 12 performance of the contract the good faith deposit by cash,
- 13 certified check, or bond, shall be forfeited to the city as
- 14 liquidated damages.

- 16 Section 2. This act shall take effect in 60 days.
