| 6 | Section 1. Definitions. |
| 7 | The following words and phrases when used in this act shall |
| 8 | have the meanings given to them in this section unless the |
| 9 | context clearly indicates otherwise: |
| 10 | "Municipality." A city, borough, incorporated town or |
| 11 | township or a home rule municipality formerly classified as a |
| 12 | city, borough, incorporated town or township. |
| 13 | Section 2. Municipalities authorized to establish municipal |
| 14 | lotteries. |
| 15 | Any municipality may, by ordinance, establish a lottery to be |
| 16 | operated by the municipality, the net proceeds of which shall be |
| 17 | used for the general operating expenses of the municipality. |
| 18 | Section 3. Requirements, limitations and restrictions. |

(a) General rule.--Any lottery established by a municipality
shall be subject to the same general requirements, limitations
and restrictions as prescribed pursuant to the act of August 26,
1971 (P.L.351, No.91), known as the State Lottery Law.

5 (b) Approval required.--The proposed ordinance providing for 6 a lottery in a municipality and any subsequent changes in the 7 manner of conducting a lottery shall be submitted to the 8 Secretary of Revenue for his review as to compliance with 9 subsection (a) and shall be subject to his approval.

10 Section 4. Other laws inapplicable.

11 No other law providing any penalty or disability for the sale 12 of lottery tickets or shares or any acts done in connection with 13 a lottery shall apply to the sale of tickets or shares or acts 14 performed with respect to a lottery authorized by this act. 15 Section 5. Repeals.

16 (a) Specific.--The provisions of 18 Pa.C.S. §§ 5512, 5513 17 and 5514 are repealed insofar as inconsistent with the 18 provisions of this act.

19 (b) General.--All other acts and parts of acts are repealed20 insofar as inconsistent with the provisions of this act.

21 Section 6. Effective date.

22 This act shall take effect in 60 days.
