AN ACT

- 1 Establishing the Family Caregiver Support Advisory Board within
- the Department of Public Welfare; and providing for its
- 3 powers and duties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Family
- 8 Caregiver Support Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Department." The Department of Public Welfare of the
- 14 Commonwealth.
- 15 "Advisory board." The Family Caregiver Advisory Board
- 16 established under this act.
- 17 Section 3. Family Caregiver Advisory Board.

- 1 (a) Establishment. -- The Family Caregiver Advisory Board
- 2 established within the Department of Public Welfare.
- 3 (b) Membership. -- The advisory board shall consist of nine
- 4 members appointed by the Governor and shall be subject to
- 5 confirmation by the Senate.
- 6 (c) Term of office.--
- 7 (1) A member of the advisory board shall serve for a
- 8 four-year term, subject to removal by the Governor. The first
- 9 members of the advisory board shall serve as follows:
- 10 (i) Three members shall have a term ending January
- 11 1, 2012.
- 12 (ii) Three members shall have a term ending January
- 13 1, 2013.
- 14 (iii) Three members shall have a term ending January
- 15 1, 2014.
- 16 (2) Before the expiration of the term of a member, the
- Governor shall appoint a successor whose term shall begin on
- 18 July 1, next following.
- 19 (3) A member shall be eligible for reappointment.
- 20 (4) If there is a vacancy of any member's office, the
- 21 Governor shall make an appointment to become immediately
- 22 effective for the unexpired term.
- 23 (5) A member of the board shall be entitled to
- 24 compensation as determined by the Executive Board and to
- 25 reimbursement for reasonable expenses incurred in the
- 26 performance of official duties of the advisory board.
- 27 (d) Eligibility. -- In order to qualify for membership on the
- 28 advisory board, the individual must be a resident of this
- 29 Commonwealth and be well informed about the needs of family
- 30 caregivers.

- 1 (e) Officers of advisory board. -- The advisory board shall
- 2 select one of its members as chairperson and another as vice
- 3 chairperson for such terms and with such duties and powers as
- 4 necessary for the performance of the functions as the advisory
- 5 board determines.
- 6 (f) Quorum.--A majority of the members of the advisory board
- 7 shall constitute a quorum for the transaction of business.
- 8 (g) Meetings.--The advisory board shall meet at least once
- 9 every three months as determined by the advisory board. The
- 10 advisory board may also meet at other times as specified by the
- 11 call of the chairperson or of a majority of the members of the
- 12 advisory board.
- 13 Section 4. Powers and duties.
- 14 The board shall advise the department on the needs of family
- 15 caregivers in programs administered by the department.
- 16 Section 5. Regulations.
- 17 The board shall promulgate the rules and regulations
- 18 necessary to administer this act.
- 19 Section 6. Effective date.
- This act shall take effect in 60 days.
