## AN ACT

- Designating a bridge on that portion of State Route 62 over the Allegheny River, Tionesta Borough, Forest County, as the Lt.
- 3 Col. Michael McLaughlin/AMVETS Post 113 Memorial Bridge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Lt. Col. Michael McLaughlin/AMVETS Post 113 Memorial
- 7 Bridge.
- 8 (a) Findings.--
- 9 (1) Lieutenant Colonel Michael McLaughlin was born and
- 10 raised in Forest County, Pennsylvania, and graduated from
- 11 West Forest High School.
- 12 (2) Lt. Col. McLaughlin was a resident of Mercer County,
- Pennsylvania, at the time of his death.
- 14 (3) Lt. Col. McLaughlin deployed to Iraq with the 2nd
- 15 Brigade, 28th Infantry Division, as brigade effects

- 1 coordinator, his duties including coordination of all lethal
- 2 and nonlethal fires.
- 3 (4) Lt. Col. McLaughlin's military awards include the
- 4 Silver Star (posthumously), the Army Commendation Medal with
- 5 three oak leaf clusters, the National Defense Service Medal,
- 6 the Army Service Ribbon, the Overseas Service Ribbon and the
- 7 Field Artillery Honorable Order of Saint Barbara.
- 8 (5) While courageously serving his country, Lt. Col.
- 9 McLaughlin became the first field grade officer of the
- 10 Pennsylvania Army National Guard to die in action since World
- 11 War II when he was killed January 5, 2006, by a suicide
- bomber at an Iraqi police recruiting station in Ramadi, Iraq.
- 13 (6) American Veterans (AMVETS) Post 113 is a veterans'
- services organization with more than 100 members, including
- 15 veterans from all services and conflicts and peacetime.
- 16 (7) AMVETS Post 113 honors all veterans and recognizes
- 17 their unselfish service.
- 18 (b) Designation. -- The bridge located on State Route 62 in
- 19 Tionesta Borough, Forest County, over the Allegheny River is
- 20 hereby designated the Lt. Col. Michael McLaughlin/AMVETS Post
- 21 113 Memorial Bridge.
- 22 (c) Signs.--The Department of Transportation shall erect and
- 23 maintain appropriate signs displaying the name of the bridge to
- 24 traffic in both directions on the bridge.
- 25 Section 2. Effective date.
- 26 This act shall take effect in 60 days.
