- 2 § 2161. Bail Enforcement Disciplinary and Performance Review
- Board.
- 4 A Bail Enforcement Disciplinary and Performance Review Board
- 5 is hereby established in the judicial branch. The board shall
- 6 have a seal engraved with its name and such other inscription as
- 7 may be necessary. A facsimile or preprinted seal may be used for
- 8 all purposes in lieu of the original seal.
- 9 § 2162. Composition of Bail Enforcement Disciplinary and
- 10 Performance Review Board.
- 11 (a) General rule. -- The Bail Enforcement Disciplinary and
- 12 Performance Review Board shall consist of:
- 13 (1) A judge of the Superior Court in regular active
- service appointed by the Supreme Court.
- 15 (2) A district justice, who need not be a member of the
- bar of this Commonwealth, appointed by the Supreme Court.
- 17 (3) A nonjudge member of the bar of this Commonwealth
- 18 appointed by the Supreme Court.
- 19 (4) A nonlawyer elector appointed by the Supreme Court.
- 20 (5) A judge of a court of common pleas in regular active
- 21 service appointed by the Governor.
- 22 (6) Two nonjudge members of the bar of this Commonwealth
- appointed by the Governor.
- 24 (7) A nonlawyer elector appointed by the Governor.
- 25 (b) Qualifications.--All members of the board must be
- 26 residents of this Commonwealth. No more than two of the four
- 27 members appointed by the Supreme Court may be registered in the
- 28 same political party. No more than two of the four members
- 29 appointed by the Governor may be registered in the same
- 30 political party. Membership of a judge or district justice shall

- 1 terminate if the member ceases to hold the judicial position
- 2 that qualified the member for the appointment. Membership shall
- 3 terminate if a member attains a position that would have
- 4 rendered the member ineligible for appointment at the time of
- 5 the appointment. A person may not serve more than four
- 6 consecutive years but may be reappointed after a lapse of one
- 7 year.
- 8 (c) Terms of office.--Members shall serve for terms of four
- 9 years.
- 10 (d) Vacancies.--A vacancy shall be filled by the respective
- 11 appointing authority for the remainder of the term to which the
- 12 member was appointed.
- 13 (e) Restrictions on activities of members.--No member,
- 14 during the member's term, may hold office in a political party
- 15 or political organization. Except for a judicial member, no
- 16 member, during the member's term, may hold a compensated public
- 17 office or public appointment.
- 18 (f) Expenses.--All members shall be reimbursed for expenses
- 19 necessarily incurred in the discharge of their official duties.
- 20 § 2163. Organization.
- 21 The Bail Enforcement Disciplinary and Performance Review
- 22 Board shall elect a chairperson annually and shall act in all
- 23 matters only with the concurrence of a majority of its members.
- 24 § 2164. Staff.
- 25 The administrative office shall provide such staff assistance
- 26 as the Bail Enforcement Disciplinary and Performance Review
- 27 Board may require.
- 28 § 2165. Powers and duties.
- 29 The Bail Enforcement Disciplinary and Performance Review
- 30 Board shall have the power to:

- 1 (1) Review bail officer performance evaluations 2 submitted by bondsmen under Subchapter C of Chapter 57
- 3 (relating to bail enforcement officers).
- 4 (2) Maintain bail enforcement officer licensing records.
- 5 (3) Receive, process and adjudicate complaints regarding 6 acts of bail enforcement officers in the performance of duty.
- 7 (4) Take disciplinary action against bail enforcement 8 officers when necessary.
- 9 (5) Exercise additional powers and perform additional duties vested in and imposed by law.
- 11 Section 2. This act shall take effect in 60 days.
