## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain

- provisions applicable as well to private and parochial 3
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in duties and powers of boards of 5
- school directors, providing for admission fees for school-6
- sponsored activities.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- as the Public School Code of 1949, is amended by adding a 11
- 12 section to read:
- 13 Section 511.1. Admission Fees for School-Sponsored
- 14 Activities. -- (a) When a fee is charged for admission to a
- 15 school-sponsored activity, United States currency shall be
- accepted as a form of payment for admission on the date of the 16
- 17 activity.

- 1 (b) Nothing in this section shall be construed to prohibit a
- 2 <u>school-sponsored activity from accepting alternative payment</u>
- 3 methods in addition to United States currency for admission to
- 4 <u>the school-sponsored activity.</u>
- 5 (c) As used in this section, the following words and phrases
- 6 shall have the meanings given to them in this subsection unless
- 7 the context clearly indicates otherwise:
- 8 "Interscholastic athletic activity" shall mean an athletic
- 9 <u>contest or competitions conducted between or among school</u>
- 10 entities or nonpublic school entities in this Commonwealth.
- 11 "School entity" shall mean a school district, intermediate
- 12 <u>unit, area career and technical school, charter school, cyber</u>
- 13 <u>charter school or regional charter school.</u>
- 14 "School-sponsored activity" shall mean an assembly, field
- 15 trip, class trip, graduation ceremony, interscholastic athletic
- 16 <u>activity</u>, <u>extracurricular activity</u>, <u>club</u>, <u>group</u>, <u>team or any</u>
- 17 activity sponsored, held or approved by a school entity within
- 18 its buildings, grounds or other location not owned or operated
- 19 by the school entity.
- 20 "United States currency" shall mean the coin and paper money
- 21 of the United States.
- 22 Section 2. This act shall take effect immediately.
