AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 2 act relating to the public school system, including certain 3 provisions applicable as well to private and parochial 4 schools; amending, revising, consolidating and changing the laws relating thereto, "increasing the amount of work of any nature which can be performed on property owned by a school 6 district without advertising and without competitive bids. The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 10 Section 1. Section 751(a) and (b) of the act of March 10, 11 1949 (P.L.30, No.14), known as the Public School Code of 1949,
- 11 1949 (P.D.30, NO.14), Known as the Public School Code of
- 12 amended February 4, 1982 (P.L.1, No.1) and June 29, 1984
- 13 (P.L.438, No.93), are amended to read:
- 14 Section 751. Work to be Done Under Contract Let on Bids;
- 15 Exception. -- (a) All construction, reconstruction, repairs,
- 16 maintenance or work of any nature, including the introduction of
- 17 plumbing, heating and ventilating, or lighting systems, upon any
- 18 school building or upon any school property, or upon any
- 19 building or portion of a building leased under the provisions of
- 20 section 703.1, made by any school district, where the entire

- 1 cost, value, or amount of such construction, reconstruction,
- 2 repairs, maintenance or work, including labor and material,
- 3 shall exceed [four thousand dollars (\$4,000)] ten thousand
- 4 <u>dollars (\$10,000)</u>, shall be done under separate contracts to be
- 5 entered into by such school district with the lowest responsible
- 6 bidder, upon proper terms, after due public notice has been
- 7 given asking for competitive bids. Whenever a board of school
- 8 directors shall approve the use of a prefabricated unit,
- 9 complete in itself, for a school building or other proper
- 10 structure to be erected upon school property, the board of
- 11 school directors may have prepared appropriate specifications
- 12 detailing the size and material desired in a particular
- 13 prefabricated unit, including all utilities such as plumbing,
- 14 heating and ventilating, and electrical work, and may advertise
- 15 for a single bid on all the work and award the contract therefor
- 16 to the lowest responsible bidder: Provided, That if due to an
- 17 emergency a school plant or any part thereof becomes unusable
- 18 competitive bids for repairs or replacement may be solicited
- 19 from at least three responsible bidders, and upon the approval
- 20 of any of these bids by the Secretary of Education, the board of
- 21 school directors may proceed at once to make the necessary
- 22 repairs or replacements in accordance with the terms of said
- 23 approved bid or bids.
- 24 (b) The board of school directors in any school district may
- 25 perform any construction, reconstruction, repairs, or work of
- 26 any nature, where the entire cost or value, including labor and
- 27 material, is less than five thousand dollars (\$5000), by its own
- 28 maintenance personnel. [The board may have any such
- 29 construction, reconstruction, repairs, or work up to ten
- 30 thousand dollars (\$10,000) performed by contract after

- 1 soliciting bids from at least three responsible bidders:
- 2 Provided, That the] The board of school directors in any school
- 3 district may authorize the secretary of the board or other
- 4 executive to award contracts for construction, reconstruction,
- 5 repairs, or work of any nature, where the entire cost or value,
- 6 including labor and material, is [four thousand dollars
- 7 (\$4,000)] ten thousand dollars (\$10,000) or less, without
- 8 soliciting competitive bids.

- 10 Section 2. Section 807.1 of the act, amended February 4,
- 11 1982 (P.L.1, No.1), is amended to read:
- 12 Section 807.1. Purchase of Supplies.--All furniture,
- 13 equipment, textbooks, school supplies and other appliances for
- 14 the use of the public schools, costing [four thousand dollars
- 15 (\$4,000)] ten thousand dollars (\$10,000) or more shall be
- 16 purchased by the board of school directors only after due
- 17 advertisement as hereinafter provided. Supplies costing [four
- 18 thousand dollars (\$4,000)] ten thousand dollars (\$10,000) or
- 19 more shall be purchased by the board of school directors only
- 20 after public notice has been given by advertisement once a week
- 21 for three (3) weeks in not less than two (2) newspapers of
- 22 general circulation. In any district where no newspaper is
- 23 published, said notice may, in lieu of such publication, be
- 24 posted in at least five (5) public places.
- 25 The board of school directors shall accept the bid of the
- 26 lowest responsible bidder, kind, quality, and material being
- 27 equal, but shall have the right to reject any and all bids, or
- 28 select a single item from any bid. The board of school directors
- 29 in any district may authorize or appoint the secretary of the
- 30 board or other executive as purchasing agent for the district,

- 1 with authority to purchase supplies costing less than [four
- 2 thousand dollars (\$4,000)] ten thousand dollars (\$10,000).
- 3 The following shall be exempt from the above provisions:
- 4 maps, music, globes, charts, educational films, filmstrips,
- 5 prepared transparencies and slides, pre-recorded magnetic tapes
- 6 and disc recordings, textbooks, games, toys, prepared kits,
- 7 flannel board materials, flash cards, models, projectuals and
- 8 teacher demonstration devices necessary for school use.
- 9 Section 3. This act shall take effect in 60 days.
