AN ACT

- 1 Authorizing and directing the Department of General Services and
- 2 The General State Authority, with the approval of the
- 3 Governor, to convey to the Redevelopment Authority of the
- 4 County of Armstrong a certain tract of land.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The Department of General Services and The
- 8 General State Authority, with the approval of the Governor, on
- 9 behalf of the Commonwealth of Pennsylvania are hereby authorized
- 10 and directed to convey to the Redevelopment Authority of the
- 11 County of Armstrong for the consideration of \$30,063.80 the
- 12 following described tract of land situate in the Borough of
- 13 Kittanning, County of Armstrong, Commonwealth of Pennsylvania,
- 14 such tract being bounded and described as follows:
- 15 Beginning at a point at the northeast corner of the herein
- 16 described tract of land at the southeast corner of lands of The
- 17 General State Authority, on the westerly line of South McKean
- 18 Street; thence along said South McKean Street south 38 degrees
- 19 53 minutes 30 seconds east 301.92 feet to a point at the corner

- 1 of South McKean Street and Walnut Street Extension; thence along
- 2 said Walnut Street Extension and disposition Parcel No.4 south
- 3 50 degrees 29 minutes 30 seconds west 165.92 feet to a point on
- 4 the easterly line of South Jefferson Alley; thence along said
- 5 alley north 38 degrees 54 minutes 00 seconds west 301.88 feet to
- 6 a point at the southwest corner of The General State Authority,
- 7 aforementioned; thence along said lands north 50 degrees 29
- 8 minutes 30 seconds east 166.02 feet to the place of beginning
- 9 containing 50,106.34 square feet more or less.
- 10 Being the same property described in "Schedule A" of the deed
- 11 conveying such property to The General State Authority from the
- 12 Redevelopment Authority of the County of Armstrong, dated March
- 13 31, 1975.
- 14 The above conveyance shall be made under and subject,
- 15 nevertheless, to all easements, servitudes and rights of others,
- 16 including, but not confined to, streets, roadways, and rights of
- 17 any telephone, telegraph, water, electric, gas, or pipeline
- 18 companies, as well as under and subject, nevertheless, to any
- 19 estate or tenancies vested in third persons, whether or not
- 20 appearing of record, for any portion of the said land or
- 21 improvements erected thereon.
- 22 Section 2. Nothing in this act shall be construed to affect
- 23 the validity of the restrictions, easements, conditions and
- 24 covenants set forth in the deed by the Redevelopment Authority
- 25 of the County of Armstrong to The General State Authority, dated
- 26 March 31, 1975, insofar as such restrictions, easements,
- 27 conditions and covenants relate to the tract of land therein
- 28 described in "Schedule B".
- 29 Section 3. The deed of conveyance shall be approved by the
- 30 Department of Justice and shall be executed by the Secretary of

- 1 General Services and the Executive Director of The General State
- 2 Authority in the name of the Commonwealth of Pennsylvania.
- 3 Section 4. All moneys received from the sale of the land
- 4 shall be deposited in the General Fund.
- 5 Section 5. This act shall take effect immediately.
