AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further defining "emergency vehicle"; and further
- 3 providing for visual and audible signals on emergency
- 4 vehicles.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The definition of "emergency vehicle" in section
- 8 102 of Title 75 of the Pennsylvania Consolidated Statutes is
- 9 amended to read:
- 10 § 102. Definitions.
- 11 Subject to additional definitions contained in subsequent
- 12 provisions of this title which are applicable to specific
- 13 provisions of this title, the following words and phrases when
- 14 used in this title shall have, unless the context clearly
- 15 indicates otherwise, the meanings given to them in this section:
- 16 * * *
- 17 "Emergency vehicle." A fire department vehicle, police
- 18 vehicle, sheriff vehicle, ambulance, blood-delivery vehicle,

- 1 hazardous material response vehicle, armed forces emergency
- 2 vehicle, one vehicle operated by a coroner or chief county
- 3 medical examiner and one vehicle operated by a chief deputy
- 4 coroner or deputy chief county medical examiner used for
- 5 answering emergency calls, or any other vehicle designated by
- 6 the State Police under section 6106 (relating to designation of
- 7 emergency vehicles by Pennsylvania State Police), or a privately
- 8 owned vehicle used in answering an emergency call when used by
- 9 any of the following:
- 10 (1) A police chief and assistant chief.
- 11 (2) A fire chief, assistant chief and, when a fire
- 12 company has three or more fire vehicles, a second or third
- 13 assistant chief.
- 14 (3) A fire police captain and fire police lieutenant.
- 15 (4) An ambulance corps commander and assistant
- 16 commander.
- 17 (5) A river rescue commander and assistant commander.
- 18 (6) A county emergency management coordinator.
- 19 (7) A fire marshal.
- 20 (8) A rescue service chief and assistant chief.
- 21 (9) A constable certified under 42 Pa.C.S. § 2942
- 22 (relating to conduct and insurance).

- 24 Section 2. Section 4571(b) of Title 75 is amended to read:
- 25 § 4571. Visual and audible signals on emergency vehicles.
- 26 * * *
- 27 (b) Police, sheriff, constable, fire and coroner or medical
- 28 examiner vehicles.--
- 29 (1) Police, sheriff, <u>constable</u>, coroner, medical
- 30 examiner or fire police vehicles may in addition to the

- 1 requirements of subsection (a) be equipped with revolving or
- 2 flashing blue lights. The combination of red and blue lights
- may be used only on police, sheriff, constable, coroner,
- 4 medical examiner or fire police vehicles.
- 5 (2) Unmarked police [and], sheriff and constable
- 6 vehicles, used as emergency vehicles and equipped with
- 7 audible warning systems, may be equipped with the lights
- 8 described in this section.
- 9 (3) Police, sheriff, constable and fire vehicles may be
- 10 equipped with a mounted rack containing one or more emergency
- warning lights or side mounted floodlights or alley lights or
- 12 all such lights.

- 14 Section 3. This act shall take effect in 60 days.
