AN ACT

- Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of 3 controlled substances, other drugs, devices and cosmetics; conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, 6 Device and Cosmetic Board; establishing schedules of 7 controlled substances; providing penalties; requiring registration of persons engaged in the drug trade and for the 8 revocation or suspension of certain licenses and 9 registrations; and repealing an act," further providing for 10 schedules of controlled substances. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 4(5) of the act of April 14, 1972 15 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, is amended by adding a subclause to 16
- 18 Section 4. Schedules of Controlled Substances.--The
- 19 following schedules include the controlled substances listed or
- 20 to be listed by whatever official name, common or usual name,
- 21 chemical name, or trade name designated.

- 1 (5) Schedule V--In determining that a substance comes within
- 2 this schedule, the secretary shall find: a low potential for
- 3 abuse relative to the substances listed in Schedule IV;
- 4 currently accepted medical use in the United States; and limited
- 5 physical dependence and/or psychological dependence liability
- 6 relative to the substances listed in Schedule IV. The following
- 7 controlled substances are included in this schedule:

- 9 (iii) Any compound, mixture, or preparation containing any
- 10 <u>detectable quantity of ephedrine, pseudoephedrine or</u>
- 11 phenylpropanolamine or any of their salts or optical isomers, or
- 12 salts of optical isomers, but shall not include any of the
- 13 <u>following:</u>
- 14 <u>1. Any compound, mixture, or preparation in liquid, liquid</u>
- 15 <u>capsule</u>, or <u>liquid</u> <u>gel</u> <u>capsule</u> <u>form</u> <u>if</u> <u>ephedrine</u>,
- 16 pseudoephedrine or phenylpropanolamine is not the only active
- 17 <u>ingredient</u>.
- 18 2. Any compound, mixture, or preparation which has been
- 19 determined by the secretary to be formulated in such a way as to
- 20 <u>effectively prevent the conversion of the active ingredient into</u>
- 21 methamphetamine or its salts or optical isomers, or salts of
- 22 optical isomers.
- 23 Section 2. This act shall take effect in 60 days.
