AN ACT

Authorizing the Department of General Services, with the 2 approval of the Governor, to sell and convey to Upper 3 Skippack Mennonite Church, certain improved land situate in the Township of Skippack, County of Montgomery, Commonwealth 5 of Pennsylvania. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Conveyance authorization. 9 The Department of General Services, with the approval of the 10 Governor, is hereby authorized and directed on behalf of the 11 Commonwealth of Pennsylvania to grant, sell and convey to Upper 12 Skippack Mennonite Church, for consideration of \$1 FAIR MARKET 13 VALUE AS DETERMINED BY AN INDEPENDENT APPRAISAL, the tract of land described in section 2. 14 15 Section 2. Property description. 16 The property to be conveyed pursuant to section 1 is the 17 following tract of land, bounded and described as follows:

- 16 CORNER; THENCE FROM SAID POINT EXTENDING ALONG THE CENTER LINE
- 17 OF CRESSMAN ROAD THE FOLLOWING COURSES AND DISTANCES; SOUTH 49
- 18 DEGREES 13 MINUTES 33 SECONDS WEST 30.13 FEET TO A POINT, A
- 19 CORNER; THENCE FROM SAID POINT EXTENDING THROUGH LANDS OF THE
- 20 COMMONWEALTH OF PENNSYLVANIA THE FOLLOWING SEVEN COURSES AND
- 21 DISTANCES; (1) NORTH 42 DEGREES 16 MINUTES 01 SECONDS WEST 415
- 22 FEET TO A POINT, A CORNER; (2) NORTH 47 DEGREES 43 MINUTES 59
- 23 SECONDS EAST 353 FEET TO A POINT, A CORNER; (3) SOUTH 42 DEGREES
- 24 16 MINUTES 01 SECONDS EAST 66 FEET TO A POINT, A CORNER; (4)
- 25 NORTH 52 DEGREES 46 MINUTES 27.4 SECONDS EAST 120 FEET TO A
- 26 POINT, A CORNER; (5) SOUTH 42 DEGREES 16 MINUTES 01 SECONDS EAST
- 27 76 FEET TO A POINT, A CORNER; (6) NORTH 52 DEGREES 46 MINUTES
- 28 27.4 SECONDS EAST 395.91 FEET TO A POINT, A CORNER; (7) SOUTH 43
- 29 DEGREES 48 MINUTES 18 SECONDS EAST 250 FEET TO A POINT ON THE
- 30 CENTER LINE OF CRESSMAN ROAD, A CORNER; THENCE FROM SAID POINT

- 1 EXTENDING ALONG THE CENTER LINE OF CRESSMAN ROAD SOUTH 46
- 2 DEGREES 11 MINUTES 42 SECONDS WEST 198.94 FEET TO THE POINT AND
- 3 PLACE OF BEGINNING.
- 4 CONTAINING 3.756 ACRES OF LAND MORE OR LESS.
- 5 Section 3. Easements, etc.
- 6 The conveyance shall be made under and subject to all
- 7 easements, servitudes and rights of others, including, but not
- 8 confined to, streets, roadways and rights of any telephone,
- 9 telegraph, water, electric, sewer, gas or pipeline companies, as
- 10 well as under and subject to any interest, estates or tenancies
- 11 vested in third persons, whether or not appearing of record, for
- 12 any portion of the land or improvements erected thereon.
- 13 Section 4. Deposit of proceeds.
- 14 The proceeds of this sale shall be paid into the State
- 15 Treasury and deposited in the General Fund.
- 16 Section 5. Approval and execution of deed.
- 17 The deed of conveyance shall be approved as provided by law
- 18 and shall be executed by the Secretary of General Services in
- 19 the name of the Commonwealth of Pennsylvania.
- 20 Section 6. Costs and fees.
- 21 Costs and fees incidental to the conveyance shall be borne by
- 22 the grantee.
- 23 Section 7. Effective date.
- 24 This act shall take effect immediately.
