## AN ACT

- 1 Amending Titles 24 (Education) and 71 (State Government) of the
- 2 Pennsylvania Consolidated Statutes, further providing for
- 3 cost-of-living increases to annuitants.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 8346(a) and 8348(a) of Title 24 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 8346. Termination of annuities.
- 9 (a) General rule.--If an annuitant returns to school service
- 10 or enters State service and elects multiple service membership,
- 11 any annuity payable to him under this part shall cease and in
- 12 the case of an annuity other than a disability annuity the
- 13 present value of such annuity, adjusted for full coverage in the
- 14 case of a joint coverage member who makes the appropriate back
- 15 contributions for full coverage, shall be frozen as of the date
- 16 such annuity ceases. In the event that [the] a cost-of-living
- 17 increase [enacted December 18, 1979] occurred during the period

- 1 of such State or school employment, the frozen present value
- 2 shall be increased, on or after the member attains
- 3 superannuation age, by the percent applicable had he not
- 4 returned to service.

- 6 § 8348. Supplemental annuities.
- 7 (a) General rule. -- Every annuitant who is in receipt of a
- 8 superannuation, withdrawal or disability annuity, shall continue
- 9 to receive such annuity [and beginning July 1, 1979, any
- 10 annuitant who retired on or prior to July 1, 1978, shall receive
- 11 a cost-of-living supplement determined as a percentage applied
- 12 to the retirement annuity as of June 30, 1979. Such cost-of-
- 13 living supplement shall be payable under the same terms and
- 14 conditions as provided under the option plan in effect as of
- 15 June 30, 1979.], and beginning January 1, 1990, and annually
- 16 thereafter, a cost-of-living supplement shall be payable to each
- 17 annuitant whose annuity has been in effect for at least 24
- 18 consecutive months. Any cost-of-living supplement provided in
- 19 this subsection shall be payable under the same terms and
- 20 conditions as provided under the option plan in effect as of
- 21 <u>December 31 of the year preceding the adjustment. As soon as</u>
- 22 possible subsequent to July 1989, and each year thereafter, the
- 23 board shall determine the percentage increase in the Consumer
- 24 Price Index for All Urban Consumers, United States City Average,
- 25 All Items, from June of the preceding calendar year to June of
- 26 the calendar year of the determination. On the basis of such
- 27 determination, each annuity shall be adjusted by the percentage
- 28 increase so determined, rounded to the nearest 0.1%. The
- 29 <u>automatic percentage increase paid in any one year shall not</u>
- 30 exceed 3%. No cost-of-living supplement shall be payable to an

- 1 <u>annuitant receiving a withdrawal annuity prior to his attainment</u>
- 2 <u>of superannuation age.</u>

- 4 Section 2. Sections 8348(b) and 8348.1 of Title 24 are
- 5 repealed.
- 6 Section 3. Sections 5706(a) and 5708(a) of Title 71 are
- 7 amended to read:
- 8 § 5706. Termination of annuities.
- 9 (a) General rule.--If the annuitant returns to State service
- 10 or enters school service and elects multiple service membership,
- 11 any annuity payable to him under this part shall cease and in
- 12 the case of an annuity other than a disability annuity the
- 13 present value of such annuity, adjusted for full coverage in the
- 14 case of a joint coverage member who makes the appropriate back
- 15 contributions for full coverage, shall be frozen as of the date
- 16 such annuity ceases. In the event that [the] a cost-of-living
- 17 increase [enacted December 18, 1979] occurred during the period
- 18 of such State or school employment, the frozen present value
- 19 shall be increased, on or after the member attains
- 20 superannuation age, by the percent applicable had he not
- 21 returned to service. This subsection shall not apply in the case
- 22 of any annuitant who may render services to the Commonwealth in

- 30 § 5708. Supplemental annuities.

- 1 (a) General rule. -- Every annuitant [who retired prior to
- 2 July 1, 1978 and] who is in receipt of a superannuation,
- 3 withdrawal or disability annuity, shall continue to receive the
- 4 annuity [to which he was entitled prior to July 1, 1979 and
- 5 beginning July 1, 1979, any annuitant retiring on or prior to
- 6 June 30, 1978 shall receive a cost-of-living supplement
- 7 determined as a percentage applied to the retirement annuity to
- 8 which he was entitled prior to July 1, 1979. Such cost-of-living
- 9 supplement shall be payable under the same terms and conditions
- 10 as provided under the option plan in effect as of June 30,
- 11 1979.], and beginning January 1, 1990, and annually thereafter,
- 12 <u>a cost-of-living supplement shall be payable to each annuitant</u>
- 13 whose annuity has been in effect for at least 24 consecutive
- 14 months. Any cost-of-living supplement provided in this
- 15 <u>subsection shall be payable under the same terms and conditions</u>
- 16 as provided under the option plan in effect as of December 31 of
- 17 the year preceding the adjustment. As soon as possible
- 18 subsequent to July 1989, and each year thereafter, the board
- 19 shall determine the percentage increase in the Consumer Price
- 20 Index for All Urban Consumers, United States City Average, All
- 21 <u>Items, from June of the preceding calendar year to June of the</u>
- 22 <u>calendar year of the determination. On the basis of such</u>
- 23 <u>determination</u>, each annuity shall be adjusted by the percentage
- 24 <u>increase so determined</u>, rounded to the nearest 0.1%. The
- 25 <u>automatic percentage increase paid in any one year shall not</u>
- 26 <u>exceed 3%. No cost-of-living supplement shall be payable to an</u>
- 27 annuitant receiving a withdrawal annuity prior to his attainment
- 28 of superannuation age.
