AN ACT

1 Making appropriations to the Treasury Department out of various
2 funds to pay replacement checks issued in lieu of outstanding
3 checks when presented and to adjust errors.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. The following sums are hereby appropriated, out
7 of the funds indicated, to the Treasury Department for the
8 fiscal year July 1, 1986, to June 30, 1987, for the payment of
9 replacement checks issued by that department:
