1 2 3 4 5 6 7 8 9 10 11	Amending the act of December 22, 1959 (P.L.1978), entitled, as amended, "An act providing for and regulating harness racing with pari-mutuel wagering on the results thereof; creating the State Harness Racing Commission as a departmental administrative commission within the Department of Agriculture and defining its powers and duties; providing for the establishment and operation of harness racing plants subject to local option; imposing taxes on revenues of such plants; disposing of all moneys received by the commission and all moneys collected from the taxes; authorizing penalties; and making appropriations," imposing an additional tax for school purposes in certain school districts.
13	The General Assembly of the Commonwealth of Pennsylvania
14	hereby enacts as follows:
15	Section 1. Section 15, act of December 22, 1959 (P.L.1978),
16	entitled, as amended, "An act providing for and regulating
17	harness racing with pari-mutuel wagering on the results thereof;
18	creating the State Harness Racing Commission as a departmental
19	administrative commission within the Department of Agriculture
20	and defining its powers and duties; providing for the
21	establishment and operation of harness racing plants subject to
22	local option; imposing taxes on revenues of such plants;

- 3 making appropriations, amended August 7, 1969 (P.L.225), is
- 4 amended to read:
- 5 Section 15. Disposition of Pari-mutuel Pools.--Every
- 6 corporation authorized under this act to conduct pari-mutuel
- 7 betting at a harness horse race meeting on races run thereat
- 8 shall distribute all sums deposited in any pari-mutuel pool to
- 9 the holders of winning tickets therein, provided such tickets be
- 10 presented for payment before April first of the year following
- 11 the year of their purchase, less fifteen per centum of the total
- 12 deposits plus the breaks, and as to harness horse race meetings
- 13 held within school districts of the first class during the years
- 14 1963, 1964, 1965, 1966, 1967, 1968, 1969, 1970 and 1971 less
- 15 seventeen per centum of the total desposits plus the breaks, and
- 16 as to ALL OTHER harness horse race meetings held within school
- 17 districts of the second class during the year 1971 and
- 18 thereafter less seventeen per centum of the total deposits plus
- 19 the breaks. At the close of each racing day, the permit holder
- 20 out of the amount retained on said day by said permit holder,
- 21 shall pay, through the Department of Revenue into the State
- 22 Treasury for credit to the State Harness Racing Fund, a tax of
- 23 five per centum of the amount wagered each day, which tax is
- 24 hereby imposed, and as to harness horse race meetings held
- 25 within school districts of the first class during the years
- 26 1963, 1964, 1965, 1966, 1967, 1968, 1969, 1970 and 1971 the
- 27 permit holder shall pay the school district in which the harness
- 28 horse race meeting is held a tax of two per centum of the amount
- 29 wagered each day, which tax is hereby imposed for general school
- 30 purposes and as to ALL OTHER harness horse race meetings held

- 1 within school districts of the second class during the year 1971 <--
- 2 and thereafter the permit holder shall pay the school district, <-
- 3 in which the harness horse race meeting is held, or if in a
- 4 <u>reorganized school district</u>, then to the unit of that district
- 5 in which such meeting is held, a tax of two per centum of the
- 6 <u>amount wagered each day, which tax is hereby imposed for school</u>
- 7 purposes, TO THE SCHOOL DISTRICTS OF THE COUNTY IN WHICH SUCH
- 8 MEETING IS HELD, A TAX OF TWO PER CENTUM OF THE AMOUNT WAGERED
- 9 EACH DAY, EACH SCHOOL DISTRICT TO RECEIVE THAT PROPORTION OF THE
- 10 TOTAL, WHICH ITS PUPIL POPULATION BEARS TO THE PUPIL POPULATION
- 11 OF THE COUNTY, WHICH TAX IS HEREBY IMPOSED FOR GENERAL SCHOOL
- 12 <u>PURPOSES</u>, and as to [other] permit holders, <u>EXCEPT IN CITIES OF</u> <
- 13 THE FIRST CLASS, a tax of two per centum of the amount wagered
- 14 each day is imposed and shall be paid to the Department of
- 15 Commerce to be distributed by the Secretary of Commerce to
- 16 eligible boroughs having a population of less than ten thousand,
- 17 eligible townships having a population of less than twelve
- 18 thousand, each of their municipality authorities, or county
- 19 authorities authorized to service the borough or township, for
- 20 projects providing for the construction, rehabilitation,
- 21 alteration, expansion, or improvement of water facilities,
- 22 sewage disposal facilities and access roads, in amounts not to
- 23 exceed twenty-five per centum of the cost thereof, in accordance
- 24 with regulations promulgated by the Secretary of Commerce and
- 25 approved by the Governor. No distribution shall be made in
- 26 connection with any project unless it is determined that the
- 27 project:
- 28 (1) Is not in conflict with programs of other departments of
- 29 the Commonwealth;
- 30 (2) Is not inconsistent with an existing development plan

- 1 for the municipality;
- 2 (3) Could not otherwise be financed;
- 3 (4) Will either strengthen the income-producing capability
- 4 of the municipality, or improve the health and safety of the
- 5 community; and
- 6 (5) Is necessary to orderly community development.
- 7 In addition, each permit holder shall be allowed to retain
- 8 the odd cents of all redistribution to be made on all mutuel
- 9 contributions exceeding a sum equal to the next lowest multiple
- 10 of ten, subject to a tax of fifty per centum of the total sum of
- 11 such odd cents, which tax is hereby imposed and shall be paid by
- 12 the permit holder to the Department of Revenue for credit to the
- 13 Pennsylvania Sire Stakes Funds, which fund is hereby
- 14 appropriated to the Pennsylvania Harness Racing Commission for
- 15 distribution in accordance with the terms of this act.
- 16 Section 2. This act shall take effect immediately.
