AN ACT

- Providing for Commonwealth support for institutions of higher 2 education to furnish learning and special counseling services for undergraduate students whose cultural, economic and educational disadvantages impair their initial ability to 4 pursue successfully higher education opportunities, and 6 making an appropriation. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Short Title. -- This act shall be known and may be 10 cited as the "Higher Education Equal Opportunity Act."
- 11 Section 2. Legislative Findings. -- The General Assembly finds
- 12 and declares that because of financial, home and community
- 13 environmental conditions, students with substantial potential
- 14 for success in college and for future leadership in the
- 15 community are unable to pursue a higher education and attain
- 16 their full educational capability. In order to combat
- 17 effectively the forces which prevent these students from
- 18 pursuing a higher education, a variety of programs and methods
- 19 must be tried.

- 1 This act is designed to provide funds to institutions of
- 2 higher education in the Commonwealth for the purpose of offering
- 3 programs to enhance the chances of disadvantaged students to
- 4 achieve their educational goals.
- 5 Section 3. Definitions.--The following words and phrases
- 6 shall have the following meanings:
- 7 (1) "Institutions of higher education" shall mean those post
- 8 secondary institutions in the Commonwealth of Pennsylvania
- 9 authorized to award degrees.
- 10 (2) "Student" shall mean any bona fide resident of the
- 11 Commonwealth of Pennsylvania who has been admitted as a full-
- 12 time student to an institution of higher education and who is
- 13 economically and educationally disadvantaged in accordance with
- 14 criteria to be established by the State Board of Education.
- 15 Section 4. Higher Education Equal Opportunity Program. -- The
- 16 Secretary of Education may, in conformance with such policies,
- 17 standards, rules and regulations adopted by the State Board of
- 18 Education, contract with institutions of higher education for
- 19 the awarding of higher education equal opportunity program
- 20 grants. Programs for which such grants may be awarded shall
- 21 include, but not be limited to; remedial learning services,
- 22 counseling services or tutorial services. Funds provided by this
- 23 act may not be used to pay tuition, room and board or other
- 24 institutional costs or fees incurred by students.
- 25 Section 5. Application for Approval of Grant.--Each
- 26 institution of higher education requesting a grant to provide a
- 27 program, as proposed in this act, shall submit an application in
- 28 such form and at such time as the Secretary of Education may
- 29 require. An application for a grant shall include a description
- 30 of the nature and the method by which all funds granted will be

- 1 used by the applicant institution to contribute to the
- 2 provision, maintenance or improvement of programs designed to
- 3 accomplish the goals of this act.
- 4 Section 6. Appropriation. -- The sum of one million dollars
- 5 (\$1,000,000), or as much thereof as may be necessary is hereby
- 6 appropriated to the Department of Education for the purposes and
- 7 administration of this act: Provided, however, That of the total
- 8 sum appropriated no more than four per cent of that amount may
- 9 be used for administration of the act: And, further provided,
- 10 That no more than ten per cent of the total sum appropriated
- 11 shall be granted to any single institution of higher education.
- 12 Section 7. Effective Date. -- This act shall take effect July
- 13 1, 1971.
