AN ACT

- 1 Authorizing the Department of Property and Supplies, with the
- 2 approval of the Governor and the Secretary of Transportation,
- 3 to sell and convey to Charles L. Matter, II, a tract of land
- 4 located in the City of Williamsport, Lycoming County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The Department of Property and Supplies, with the
- 8 approval of the Governor and the Secretary of Transportation, is
- 9 hereby authorized on behalf of the Commonwealth of Pennsylvania,
- 10 to convey to Charles L. Matter, II, for such consideration as an
- 11 independent appraisal obtained through the Department of
- 12 Property and Supplies shall determine and the Attorney General
- 13 shall approve, the following tract of land situate in the Tenth
- 14 Ward of the City of Williamsport, Lycoming County, Pennsylvania,
- 15 described as follows:
- 16 Beginning at an iron pin on the eastern line of Walker Street <
- 17 at the center of a former 16 foot alley said iron pin being
- 18 110.00 feet south of the intersection of the eastern line of
- 19 Walker Street and the southern line of Dix Street; thence south

- 1 86 degrees 48 minutes east 90.00 feet along the center line of
- 2 said alley to an iron pin; thence south 4 degrees west 58.50
- 3 feet to an iron pin both lines being common to the adjoining
- 4 property of Charles L. Matter, II, et ux; then north 53 degrees
- 5 32 minutes 24 seconds west 106.65 feet to the point of
- 6 beginning, containing .06 acres.
- 7 BEGINNING AT AN IRON PIN ON THE NORTHERN RIGHT-OF-WAY LINE OF <----
- 8 THE WILLIAMSPORT MUNICIPAL WATER AUTHORITY, SAID BEGINNING POINT
- 9 BEING SOUTH 86 DEGREES 48 MINUTES EAST, 16.87 FEET FROM AN IRON
- 10 PIN AT THE INTERSECTION OF THE NORTHERN RIGHT-OF-WAY LINE OF
- 11 SAID WILLIAMSPORT MUNICIPAL WATER AUTHORITY, AND THE EASTERN
- 12 LINE OF WALKER STREET.
- 13 THENCE FROM THE SAID PLACE OF BEGINNING AND ALONG THE LINES
- 14 OF LAND OF CHARLES L. MATTER, ET AL, BY THE TWO FOLLOWING
- 15 COURSES AND DISTANCES. FIRST: SOUTH 86 DEGREES 48 MINUTES EAST,
- 16 73.13 FEET TO AN IRON PIN. SECOND: SOUTH 4 DEGREES 00 MINUTES
- 17 WEST, 50.27 FEET TO AN IRON PIN ON THE NORTHERN RIGHT-OF-WAY
- 18 LINE OF THE AFORESAID WILLIAMSPORT MUNICIPAL WATER AUTHORITY.
- 19 THENCE ALONG THE NORTHERN RIGHT-OF-WAY LINE OF SAID WATER
- 20 AUTHORITY, NORTH 52 DEGREES 02 MINUTES WEST, 88.16 FEET TO THE
- 21 PLACE OF BEGINNING, CONTAINING 0.05 ACRE.
- 22 Section 2. The deed of conveyance shall be approved by the
- 23 Department of Justice and shall be executed by the Department of
- 24 Property and Supplies in the name of the Commonwealth of
- 25 Pennsylvania.
- 26 SECTION 3. ALL MONEYS RECEIVED FROM THE SALE OF THE LAND

- 27 SHALL BE DEPOSITED IN THE MOTOR LICENSE FUND.
- 28 Section 3 4. This act shall take effect immediately.
