- 7 SECTION 16.1. THE FOLLOWING OFFICERS OF THE SENATE WHO SHALL
- 8 BE APPOINTED BY THE PRESIDENT PRO TEMPORE, SHALL, IN ADDITION TO
- 9 THEIR SALARIES AS MEMBERS OF THE GENERAL ASSEMBLY, RECEIVE THE
- 10 FOLLOWING AMOUNTS AS ADDITIONAL COMPENSATION:
- 11 (1) MAJORITY POLICY CHAIRMAN AT AN ANNUAL SALARY OF TWO
- 12 THOUSAND DOLLARS (\$2,000); AND
- 13 (2) MAJORITY CAUCUS ADMINISTRATOR AT AN ANNUAL SALARY OF TWO
- 14 THOUSAND DOLLARS (\$2,000).
- 15 <u>SECTION 16.2. THE FOLLOWING OFFICER OF THE SENATE WHO SHALL</u>
- 16 BE APPOINTED BY THE MINORITY LEADER, SHALL, IN ADDITION TO HIS
- 17 SALARY AS A MEMBER OF THE GENERAL ASSEMBLY, RECEIVE THE
- 18 FOLLOWING AMOUNT AS ADDITIONAL COMPENSATION:
- 19 (1) MINORITY CAUCUS ADMINISTRATOR AT AN ANNUAL SALARY OF TWO
- 20 THOUSAND DOLLARS (\$2,000).
- 21 <u>Section 33.1. The following employe of the House of</u>
- 22 Representatives shall be appointed by the Majority Policy
- 23 Chairman of the House of Representatives, who for the purpose of
- 24 this act shall be deemed an officer of the House of
- 25 Representatives to serve at his pleasure and receive the
- 26 <u>compensation and perform the duties herein specified:</u>
- 27 (1) One secretary at an annual salary of six thousand six
- 28 <u>hundred dollars (\$6,600)</u>, plus those percentages designated and
- 29 payable to other employes under this act as increases or
- 30 increments, provided that the appointee herein meets the

- 1 requirements prescribed by this act for receiving such increases
- 2 <u>or increments.</u>
- 3 <u>Section 33.2. The following employe of the House of</u>
- 4 Representatives shall be appointed by the Majority Caucus
- 5 Administrator, who for the purpose of this act shall be deemed
- 6 <u>an officer of the House of Representatives, to serve at his</u>
- 7 pleasure and receive the compensation and perform the duties
- 8 herein specified:
- 9 (1) One secretary at the annual salary of six thousand six
- 10 hundred dollars (\$6,600), plus those percentages designated and
- 11 payable to other employes under this act as increases or
- 12 <u>increments</u>, provided that the appointee herein meets the
- 13 requirements prescribed by this act for receiving such increases
- 14 or increments.
- 15 <u>Section 33.3. The following employe of the House of</u>
- 16 Representatives shall be appointed by the Minority Caucus
- 17 Administrator, who for the purpose of this act shall be deemed
- 18 an officer of the House of Representatives, to serve at his
- 19 pleasure and receive the compensation and perform the duties
- 20 herein specified:
- 21 (1) One secretary at the annual salary of six thousand six
- 22 hundred dollars (\$6,600), plus those percentages designated and
- 23 payable to other employes under this act as increases or
- 24 increments, provided that the appointee herein meets the
- 25 requirements prescribed by this act for receiving such increases
- 26 or increments.
- 27 Section 2. Section 34 of the act is amended to read:
- 28 Section 34. The following officers of the House of
- 29 Representatives, in addition to their salaries as members of the
- 30 General Assembly shall receive the following amounts as

- 1 additional compensation: Speaker of the House, ten thousand five
- 2 hundred dollars (\$10,500); Majority Leader, eight thousand five
- 3 hundred dollars (\$8,500); Majority Whip, four thousand dollars
- 4 (\$4,000); Majority Caucus Chairman, three thousand five hundred
- 5 dollars (\$3,500); Majority Caucus Secretary, two thousand
- 6 dollars (\$2,000); Majority Policy Chairman, two thousand dollars
- 7 (\$2,000); Majority Caucus Administrator, two thousand dollars
- 8 (\$2,000); Minority Leader, eight thousand five hundred dollars
- 9 (\$8,500); Minority Whip, four thousand dollars (\$4,000);
- 10 Minority Caucus Chairman, three thousand five hundred dollars
- 11 (\$3,500); Minority Caucus Secretary, two thousand dollars
- 12 (\$2,000); Minority Policy Chairman, two thousand dollars
- 13 (\$2,000); Minority Caucus Administrator, two thousand dollars
- 14 (\$2,000).
- 15 Section 3. This act shall take effect immediately.
