AN ACT

Amending the act of January 24, 1966 (1965 P.L.1509, No.531), entitled "An act relating to, regulating, taxing, supervising 3 and controlling the placing of insurance on risks located in the Commonwealth of Pennsylvania with insurers not licensed to transact insurance business in Pennsylvania, permitting 6 licensed insurers to afford coverage which may be placed with 7 unlicensed insurers, providing fees and penalties, and repealing certain existing laws, " changing conditions related 8 to an unlicensed insurer being or becoming an eligible 9 10 surplus lines insurer. 11 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 12 13 Section 1. Clause (2) of subsection (a) of section 7, act of 14 January 24, 1966 (1965 P.L.1509, No.531), entitled "An act relating to, regulating, taxing, supervising and controlling the 15 16 placing of insurance on risks located in the Commonwealth of Pennsylvania with insurers not licensed to transact insurance 17 18 business in Pennsylvania, permitting licensed insurers to afford 19 coverage which may be placed with unlicensed insurers, providing 20 fees and penalties, and repealing certain existing laws," is

- 1 Section 7. Eligible Surplus Lines Insurers. -- (a) No surplus
- 2 lines agent shall place any insurance with any unlicensed
- 3 insurer which is not then an eligible surplus lines insurer. No
- 4 unlicensed insurer shall be or become an eligible surplus lines
- 5 insurer unless declared eligible by the commissioner in
- 6 accordance with the following conditions:

- 8 (2) The insurer must be currently a licensed insurer in the
- 9 state or country of its domicile as to the kind or kinds of
- 10 insurance which it proposes to provide [In addition it must have
- 11 been (i) such an insurer for not less than one full year
- 12 preceding, or (ii) must be a subsidiary of an already eligible
- 13 surplus lines insurer which has been so eligible for a period of
- 14 not less than one full year preceding, or (iii) must be a
- 15 subsidiary of an insurer licensed in Pennsylvania, which has
- 16 been so licensed for a period of not less than one full year
- 17 preceding.] and shall have been so currently licensed for a
- 18 minimum period of at least three years immediately preceding its
- 19 seeking to be declared an eligible surplus lines insurer.

- 21 Section 2. This act shall take effect immediately.
