AN ACT

- 1 Amending the act of August 21, 1953 (P.L.1273, No.361), entitled
- 2 "An act to regulate the business of private detectives,
- 3 investigators and watch, guard, or patrol agencies, and the
- 4 licensing thereof in each county; providing penalties,"
- 5 permitting certain police officers to apply for licenses.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Subsection (a) of section 4, act of August 21,
- 9 1953 (P.L.1273, No.361), known as "The Private Detective Act of
- 10 1953, amended April 30, 1957 (P.L.98, No.40), is amended to
- 11 read:
- 12 Section 4. Application for Licenses. -- * * *
- 13 (a) If the applicant is a person, the application shall be
- 14 signed and verified by such person, and if the applicant is a
- 15 partnership or association, the application shall be signed and
- 16 verified by each individual composing or intending to compose
- 17 such partnership or association. The application shall state the
- 18 full name, age, residence, present and previous occupations, of

- 1 each person or individual so signing the same, that he is a
- 2 citizen of the United States, and shall also specify the name of
- 3 the city, borough, township, or incorporated town, stating the
- 4 street and number if the premises have a street and number, and
- 5 otherwise such apt description as will reasonably indicate the
- 6 location thereof, where is to be located the principal place of
- 7 business, and the bureau, agency, sub-agency, office or branch
- 8 office for which the license is desired, and such further facts
- 9 as may be required by the court of [quarter sessions] common
- 10 pleas, to show the good character, competency and integrity of
- 11 each person or individual so signing such application. Each
- 12 person or individual signing such application shall, together
- 13 with such application, submit to the court of [quarter sessions]
- 14 common pleas his photograph, in duplicate, in passport size, and
- 15 also fingerprints of his two hands, recorded in such manner as
- 16 may be specified by the court of [quarter sessions] common
- 17 <u>pleas</u>. Before approving such application, it shall be the duty
- 18 of the court of [quarter sessions] common pleas to compare such
- 19 fingerprints with fingerprints of criminals now or hereafter
- 20 filed in the records of the Pennsylvania State Police. Every
- 21 such applicant shall establish, to the satisfaction of the court
- 22 of [quarter sessions] common pleas and by at least two duly
- 23 acknowledged certificates, that such applicant, if he be a
- 24 person, or, in the case of a partnership, association, or
- 25 corporation, at least one member of such partnership,
- 26 association, or corporation, has been regularly employed as a
- 27 detective, or shall have been a member of the United States
- 28 government investigative service, a sheriff, a member of the
- 29 Pennsylvania State Police, or a member of a [city] police
- 30 department of any municipality having a rank or grade higher

- 1 than that of patrolman, for a period of not less than three
- 2 years. Such application shall be approved as to each person or
- 3 individual so signing the same by not less than five reputable
- 4 citizens of the community in which such applicant resides or
- 5 transacts business, or in which it is proposed to own, conduct,
- 6 manage or maintain the bureau, agency, sub-agency, office or
- 7 branch office for which the license is desired, each of whom
- 8 shall certify that he has personally known the said person or
- 9 individual for a period of at least five years prior to the
- 10 filing of such application, that he has read such application
- 11 and believes each of the statements made therein to be true,
- 12 that such person is honest, of good character, and competent,
- 13 and not related or connected to the person so certifying by
- 14 blood or marriage. The certificate of approval shall be signed
- 15 by such reputable citizens and duly verified and acknowledged by
- 16 them before an officer authorized to take oaths and
- 17 acknowledgment of deeds.

- 19 Section 2. This act shall take effect immediately.
