14	hereby enacts as follows:
15	Section 1. The title, act of April 27, 1937 (P.L.318,
16	No.90), known as "The Pennsylvania Plant Pest Act of 1937," is

- 6 Section 2. Section 2 of the act is amended by adding a
- 7 subsection to read:
- 8 Section 2. For the purpose of this act, the following terms
- 9 shall be construed respectively to mean:

- 11 (1) "Fruit tree improvement program" means a program to
- 12 provide regulations pertaining to the establishment of standards
- 13 of freedom from pests for fruit tree nursery stock in the
- 14 Commonwealth by indexing candidate seed and scion trees for all
- 15 known plant viruses as well as provide the fruit tree nurserymen
- 16 with "virus free" plant material for propagation.
- 17 Section 3. Sections 6 and 9 of the act are amended to read:
- 18 Section 6. The department shall cause to be issued to
- 19 nurserymen in this State, after the nursery stock in their
- 20 nurseries has been officially inspected as provided in this act,
- 21 and found to be apparently free from any plant pests, a
- 22 certificate of inspection, setting forth the fact of such
- 23 inspection and the number of acres, or fraction thereof
- 24 inspected. Said certificate shall be valid, not to exceed one
- 25 year from [October first] the date established by rule or
- 26 <u>regulation</u>, and shall not be transferable or used to cover
- 27 uninspected, infested or infected nursery stock from any source.
- 28 Section 9. Nurserymen, dealers and nursery agents selling or
- 29 delivering nursery stock in this State, except as herein
- 30 otherwise provided, shall make application in writing [before

- 1 July first of each year] by the date established by rule or
- 2 <u>regulation</u>, to the department for inspection of their nursery
- 3 stock growing in this State, or failing to give such notice,
- 4 such nurserymen, dealers or agents shall be liable for any
- 5 additional expense of inspection of said nursery stock.
- 6 Section 4. The act is amended by adding a section to read:

- 7 <u>Section 9.1. Fees for fruit tree improvement program may</u>
- 8 SHALL be established by the department through rules and
- 9 regulations developed in cooperation with a committee of Fruit
- 10 <u>Tree Nurserymen</u>.
- 11 Section 5. Sections 10 and 11 of the act are amended to
- 12 read:
- 13 Section 10. Every dealer located either within or without
- 14 the State, engaged in or about to engage in selling or
- 15 soliciting orders for nursery stock within this State, shall
- 16 secure a dealer's certificate [by furnishing a sworn affidavit]
- 17 which will serve as verification that he will buy and sell only
- 18 stock which has been duly inspected and certified by an official
- 19 State or Federal inspector, and he shall furnish the inspector
- 20 on demand a list of all sources from which he secures his stock.
- 21 Section 11. Nurserymen, dealers or other persons residing or
- 22 doing business outside the State [desiring] who desire to
- 23 solicit orders for nursery stock in the State, shall [upon
- 24 filing with the department a certified copy of their original
- 25 current resident State certificate, together with a statement
- 26 setting forth the exact acreage owned by the applicants and the
- 27 acreage being grown for them on contract, be entitled to a
- 28 certificate permitting such persons to solicit orders for
- 29 nursery stock in this State] be entitled to solicit orders in
- 30 this State provided they are certified or licensed and their

- 1 name appears on the official State Directories of Registered
- 2 <u>Nurseries and Nursery Dealers issued annually from the state in</u>
- 3 which their business is conducted.
- Section 6. This act shall take effect immediately. 4
