AN ACT

- 1 Defining prohibited conduct by public officers and certain other
- 2 persons, providing for removal or suspension from office of
- 3 certain persons, and providing penalties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. "Agency" shall mean any unit of government of the
- 7 Commonwealth, a political subdivision, authority or other
- 8 organization created by or pursuant to statute that has for its
- 9 purpose the performance of an essential government function.
- 10 "Authorized person: shall mean a public official or other
- 11 government employee authorized to issue payment, approve the
- 12 compensation of, hire, dismiss or suspend a public official or
- 13 government employee.
- "Class One government position" shall mean (i) a management
- 15 level position directly involved in the determination of policy
- 16 or responsibly directing the implementation thereof; (ii) or any

- 1 law enforcement agency or law enforcement position or office in
- 2 any agency.
- 3 Section 2. (a) No person shall be eligible for nomination,
- 4 election or appointment to any public office or any State or
- 5 county political party office nor shall any person continue to
- 6 hold said offices who pleads nolo contendere or guilty or is
- 7 convicted in a court of record of a felony.
- 8 (b) No person shall be employed or continue to hold any
- 9 Class One government position who pleads nolo contendere or
- 10 guilty or is convicted in a court of record of any felony.
- 11 (c) Any person indicted for a felony involving an abuse of
- 12 his office or abuse of a Class One government position shall be
- 13 suspended without compensation and without prejudice pending a
- 14 determination through conviction or acquittal relative to said
- 15 indictment. Any person acquitted of the offense set forth in the
- 16 indictment shall be entitled to full recovery of any
- 17 compensation so withheld.
- 18 Section 3. (a) An authorized person who hires, continues to
- 19 employ, issues payment or approves the compensation of a person
- 20 who pleads nolo contendere or guilty, or is convicted in a court
- 21 of record of a felony or knowing or having reason to know of
- 22 such pleading on conviction, shall be guilty of a misdemeanor of
- 23 the second degree as defined by the Crimes Code.
- 24 (b) An authorized person who hires, issues payment or
- 25 approves the compensation or fails to suspend a person who is
- 26 indicted for a felony which involves the abuse of his office or
- 27 knowing or having reason to know of such indictment, shall be
- 28 guilty of a misdemeanor of the second degree as defined by the
- 29 Crimes Code.
- 30 Section 4. The executive board, subject to the approval of

- 1 the Attorney General, shall determine the positions of
- 2 government within the Executive branch of the Commonwealth which
- 3 are management level and law enforcement positions. The Attorney
- 4 General shall determine, within 30 days of receipt of a request
- 5 from an authorized person affected by the provisions of this act
- 6 (i) whether a position of government in any other agency is a
- 7 management level or law enforcement position; and (ii) whether
- 8 an indictment for a felony involves an abuse of office or
- 9 government position. Any authorized person who relies upon a
- 10 determination of the Attorney General or executive board made in
- 11 accordance with this section shall not be guilty of any
- 12 violation of this act. An authorized person who continues to
- 13 employ or compensate a person or who fails to suspend such
- 14 person pending receipt of such determination from the Attorney
- 15 General shall not be guilty of a violation of this act provided
- 16 the authorized person seeks such a determination with reasonable
- 17 dispatch.
- 18 Section 5. This act shall in no way repeal any provision of
- 19 the act of August 14, 1963 (P.L.1048, No.452), entitled "An act
- 20 providing for the forfeiture of office of public officers
- 21 convicted of certain crimes."
- 22 Section 6. This act shall take effect immediately.
