AN ACT

- 1 Authorizing the Department of Property and Supplies, with the
- 2 approval of the Governor and the Chairman of the Delaware
- River Joint Toll Bridge Commission, to sell and convey to The
- 4 Bell Telephone Company of Pennsylvania a tract of land
- 5 located in the Borough of New Hope, Bucks County,
- 6 Pennsylvania.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The Department of Property and Supplies, with the
- 10 approval of the Governor and the Chairman of the Delaware River
- 11 Joint Toll Bridge Commission, is hereby authorized on behalf of
- 12 the Commonwealth of Pennsylvania to convey to The Bell Telephone
- 13 Company of Pennsylvania, for such consideration as an
- 14 independent appraisal obtained through the Department of
- 15 Property and Supplies and paid for by the grantee shall
- 16 determine and the Attorney General shall approve.
- 17 All that certain tract of land, with the buildings thereon
- 18 erected, situate in the Borough of New Hope, County of Bucks,
- 19 Commonwealth of Pennsylvania, described according to a Plan of
- 20 Survey thereof made by Edward B. Blumrick, Registered Land

- 1 Surveyor, dated December 2, 1974, as follows to wit:
- 2 Beginning at a point, a marble monument, found, on the
- 3 easterly edge of the tow path of the canal (formerly owned by
- 4 the Lehigh Coal and Navigation Company and now owned by the
- 5 Commonwealth of Pennsylvania), said point also being the
- 6 northwesterly corner of lands now or late of Joseph L. Reading;
- 7 thence along the easterly side of the tow path and a chain link
- 8 fence, north 4 degrees, 30 minutes, 23 seconds west, a distance
- 9 of 122.55 feet to a marble monument, found, being also the
- 10 southwesterly corner of lands now or later of Walter Bair;
- 11 thence along the same and the chain link fence and lands of the
- 12 Borough of New Hope, north 89 degrees, 57 minutes, 46 seconds
- 13 east, a distance of 197.67 feet to a marble monument, found,
- 14 being also the northwesterly corner of lands now or later of
- 15 David A. Guttentag; thence along the same and the chain link
- 16 fence and lands now or late of Robert W. Hilton and Kenneth
- 17 Gibson, south 7 degrees, 23 minutes, 34 seconds east, a distance
- 18 of 123.26 feet to a marble monument, found, being also the
- 19 northwesterly corner of lands now or late of Hampton Hayes and
- 20 the northeasterly corner of a 30 foot wide right-of-way, first
- 21 set off in deed of John C. Parry, et ux, to Joseph Lacey, May
- 22 31, 1853, said right-of-way leading to the herein described
- 23 property from Fisher's Alley; thence still along the chain link
- 24 fence, same also being along the northerly end of the said 30
- 25 foot right-of-way and adjoining other lands of The Bell
- 26 Telephone Company of Pennsylvania and the aforesaid lands of
- 27 Joseph L. Reading, south 89 degrees, 59 minutes west, a distance
- 28 of 203.90 feet to the first mentioned point and place of
- 29 beginning.
- 30 Containing 24,545 square feet of land, more or less. (0.563

- 1 acres)
- 2 County parcel number 27-6-92.
- 3 Together with the free and uninterrupted use of the aforesaid
- 4 right-of-way or passage, 30 feet in width, extending over the
- 5 aforesaid lands formerly of said John C. Parry and between the
- 6 said Hayes' lands and the aforesaid other lands of The Bell
- 7 Telephone Company of Pennsylvania; and
- 8 Together with the rights and privileges of the hereinafter
- 9 referred to 12 foot wide road and any extension thereof over
- 10 lands contiguous to the hereinbefore described premises, both to
- 11 the south and to the north.
- 12 Being the same premises which Jane Fields, widow, et al, by
- 13 deed dated September 9, 1932, and recorded in Bucks County in
- 14 Deed Book 621, page 132, conveyed unto the Commonwealth of
- 15 Pennsylvania, in fee.
- 16 Subject to the privilege of a 12 foot wide road over the
- 17 westerly side of the above described premises, as contained in
- 18 deed from Elias Ely, et ux, dated April 1, 1834, and recorded in
- 19 Deed Book 63, page 18.
- 20 Under and subject, nevertheless, to any and all operative
- 21 title restrictions, easements, covenants, servitudes or
- 22 conditions of record, or as may be visible upon the property.
- 23 And the recital of the above mentioned rights shall not be
- 24 construed as an acknowledgement of the validity thereof, an
- 25 extension thereof or a renewal thereof in the event that they,
- 26 or any of them, do not affect the premises hereby conveyed or
- 27 have expired or become unenforceable by their own terms or by
- 28 limitations, violation or for any other reason.
- 29 Section 2. The conveyance shall be made together with all
- 30 rights and privileges, and under and subject to all operative

- 1 title restrictions, easements, covenants, servitudes or
- 2 conditions of record, or as may be visible upon the property, as
- 3 hereinbefore set forth.
- 4 Section 3. The said land, under such lease agreement between
- 5 The Bell Telephone Company of Pennsylvania and the Borough of
- 6 New Hope as shall be mutually acceptable to the parties, shall
- 7 be further subject to the unrestricted right to use by the
- 8 borough for any municipal purposes for a period of five years
- 9 from date of the conveyance provided for herein, and thereafter
- 10 until such time as the telephone company requires the property,
- 11 or any portion or portions thereof, for its own business
- 12 purposes: Provided, however, That the borough shall be
- 13 responsible for all taxes on the entirety of said property for
- 14 the said five year period, and thereafter for all or such
- 15 portion of the taxes as the area of the borough's continued use
- 16 of the property bears to the area of the entire property.
- 17 Section 4. The deed of conveyance shall be approved by the
- 18 Department of Justice and shall be executed by the Department of
- 19 Property and Supplies in the name of the Commonwealth of
- 20 Pennsylvania.
- 21 Section 5. This act shall take effect immediately.
