35 The General Assembly of the Commonwealth of Pennsylvania

Section 1. itemizing projects for capital budget purposes," is amended by 1 amending the total for clause X. adding an item to clause X., 2 3 amending the total for clause XVI. and amending item (1) of 4 clause XVI. to read: 5 Section 7.
