## AN ACT

Amending the act of May 31, 1933 (P.L.1108, No.272), entitled, as amended, "An act providing for the appointment, promotion, 2 3 reduction, removal and reinstatement of paid officers, 4 firemen and employes of fire departments and of fire alarm operators and fire box inspectors in the bureaus of electricity in cities of the third class; defining the powers 6 7 and duties of civil service commissions for such purposes; and fixing penalties, "further providing for reductions for reasons of economy. The General Assembly of the Commonwealth of Pennsylvania 10 11 hereby enacts as follows: 12 Section 1. Section 11, act of May 31, 1933 (P.L.1108, No.272), entitled, as amended, "An act providing for the 13 appointment; promotion, reduction, removal and reinstatement of 14 15 paid officers, firemen and employes of fire departments and of fire alarm operators and fire box inspectors in the bureaus of 16 17 electricity in cities of the third class; defining the powers 18 and duties of civil service commissions for such purposes; and fixing penalties," is amended to read: 19 20 Section 11. If for reasons of economy, or other reasons, it

shall be deemed necessary by any city to reduce the number of

- 1 paid members of any fire department, or the number of fire alarm
- 2 operators or fire box inspectors in the bureau of electricity,
- 3 then such city shall follow the following procedure:
- 4 [First. If there are any paid firemen, fire alarm operators
- 5 or fire box inspectors eligible for retirement under the terms
- 6 of any pension fund, then such reduction in numbers shall be
- 7 made by retirement on pension of all the oldest in age and
- 8 service.
- 9 Second. If the number of paid firemen, fire alarm operators
- 10 and fire box inspectors eligible for retirement under the
- 11 pension fund of said city, if any, is insufficient to effect the
- 12 reduction in number desired by said city, or if there is no
- 13 eligible person for retirement, or if no pension fund exists in
- 14 said city, then the] The reduction shall be effected by
- 15 suspending the last man or men, including probationers, that
- 16 have been appointed. Such removal shall be accomplished by
- 17 suspending in numerical order, commencing with the last man
- 18 appointed, all recent appointees until such reduction shall have
- 19 been accomplished. Whenever such fire department or fire alarm
- 20 operators or fire box inspectors in the bureau of electricity
- 21 shall again be increased in numbers to the strength existing
- 22 prior to such reduction of members, or if any vacancies occur,
- 23 the employes suspended under the terms of this act shall be
- 24 reinstated to their former class before any new appointees are
- 25 appointed.
- 26 Section 2. This act shall take effect in 60 days.
