AN ACT

- 1 Amending the act of April 29, 1959 (P.L.58, No.32), entitled "An act consolidating and revising the Vehicle Code, the Tractor
- Code, the Motor Vehicle Financial Responsibility Act and
- 4 other acts relating to the ownership, possession and use of
- 5 vehicles and tractors, " removing the registration processing
- 6 fee for certain veterans.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Subsections (a) and (b) of section 729, act of
- 10 April 29, 1959 (P.L.58, No.32), known as "The Vehicle Code,"
- 11 amended December 16, 1975 (No.149), are amended to read:
- 12 Section 729. Exemptions from Fees.--
- 13 (a) No fee shall be paid under this act by the Commonwealth,
- 14 the Federal Government, any political subdivision, or another
- 15 state, and no fee shall be charged for title or registration of:
- 16 (1) Any vehicle owned by a foreign national with the rank of
- 17 vice consul or higher assigned to a consulate in this
- 18 Commonwealth provided that citizens of the United States are
- 19 granted reciprocal exemptions.

- 1 (2) Any vehicle owned by a volunteer fire, rescue or
- 2 ambulance association.
- 3 (3) Any motor bus or motor omnibus owned by a mass
- 4 transportation system.
- 5 (4) Veterans who lost a limb or eye or who became partially
- 6 paralyzed while serving in the armed forces of the United States
- 7 <u>during any period of war or armed conflict. Only one (1)</u>
- 8 vehicle, weighing not more than nine thousand (9,000) pounds,
- 9 shall be registered for any veteran.
- 10 (b) No registration fee shall be charged for vehicles owned
- 11 by any of the following but the department shall charge a fee of
- 12 ten dollars (\$10.00) to cover the costs of processing for
- 13 issuing or renewing the registration:
- 14 (1) Any person who is retired and receiving social security
- 15 or other pension and whose total income does not exceed seven
- 16 thousand five hundred dollars (\$7,500.00) per year. Said person
- 17 shall be the principal operator of the vehicle but may from time
- 18 to time authorize another person to operate the vehicle in his
- 19 or her stead. Only one (1) vehicle, weighing not more than nine
- 20 thousand (9,000) pounds, may be registered to any person under
- 21 this paragraph.
- 22 (2) Humane society.
- 23 (3) Nonprofit youth center.
- 24 (4) American Red Cross.
- 25 (5) Church.
- 26 (6) Girl Scouts of America.
- 27 (7) Boy Scouts of America.
- 28 (8) Salvation Army.
- 29 (9) Duly chartered posts of national veterans'
- 30 organizations.

- 1 (10) Young Men's Christian Association.
- 2 (11) Young Men's Hebrew Association.
- 3 (12) Young Women's Christian Association.
- 4 (13) Young Women's Hebrew Association.
- 5 (14) Jewish Community Center.
- 6 (15) Nonprofit corporations of musical marching groups of
- 7 youths.
- 8 [(16) Veterans who lost a limb or eye or who became
- 9 partially paralyzed while serving in the armed forces of the
- 10 United States during any period of war or armed conflict. Only
- 11 one (1) vehicle, weighing not more than nine thousand (9,000)
- 12 pounds, shall be registered for any veteran.]
