AN ACT

- 1 Authorizing members of the General Assembly to employ an
- 2 assistant to work in the home district; creating a Home
- 3 District Assistant Advisory Committee establishing powers and
- 4 duties for assistants of the committees; and making an
- 5 appropriation.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Legislative Purpose. -- This act shall be known as
- 9 the "Home District Assistant Act of 1976." Its purpose shall be
- 10 to increase the accessibility of each Pennsylvania voter to his
- 11 or her State Representative and State Senator.
- 12 Section 2. Home District Assistant.--Each State
- 13 Representative and each State Senator may hire one person as a
- 14 home district assistant at a salary of \$9,000 a year. The home
- 15 district assistant shall not be related to any member of the

- 1 State Legislature by blood or marriage. Upon his or her
- 2 appointment, he or she shall file a resume of prior experience
- 3 with the Chief Clerk's Office. He or she shall be required to
- 4 work an average of at least 40 hours a week and shall file time
- 5 sheets with the Chief Clerk's Office once a month.
- 6 Section 3. Tasks of the Home District Assistant. -- The
- 7 purpose of the home district assistant position shall be to
- 8 better serve the people of that legislator's district. Each
- 9 legislator who elects to have a home district assistant shall be
- 10 responsible for his or her supervision. Each legislator may
- 11 assign his or her home district assistant the task of:
- 12 (1) Scheduling meetings with individual constituents,
- with farm organizations, business organizations, labor
- organizations, religious congregations, citizens
- organizations, and news media.
- 16 (2) Supervising the composition and distributions of all
- 17 reports and questionnaires that the legislator may issue.
- 18 (3) Researching proper language for bills and the
- 19 effects of proposed bills through reading, interviewing, and
- 20 eliciting opinions.
- 21 (4) Listening to constituents complaints about
- 22 governmental performance and seeking appropriate remedies.
- 23 (5) Advising a legislator for whom he or she works about
- 24 constituents feelings and governmental policies.
- 25 (6) Supervising volunteers who wish to help out.
- 26 (7) Serving as a liaison with county, borough, and
- 27 township governments, and school districts and the
- legislator.
- 29 (8) Handling appropriate clerical and record keeping
- 30 duties.

- 1 Section 4. Appointment of Committee; Duties.--(a) The
- 2 Speaker of the House and the President pro tempore of the Senate
- 3 shall jointly appoint 20 registered voters in Pennsylvania, no
- 4 more than ten of which shall be members of the same political
- 5 party to serve, without compensation, as members of the Home
- 6 Districts Assistant Advisory Committee. The 20 members shall
- 7 elect one other member by majority vote.
- 8 (b) The Home District Assistant Advisory Committee shall
- 9 have the following duties:
- 10 (1) To recommend qualified people to serve as home
- district assistants to any legislator who requests their help
- in finding a qualified person.
- 13 (2) To make recommendations to the General Assembly, the
- Governor, and the public as to how home district assistants
- can most effectively fulfill their duties to meet public
- 16 needs.
- 17 (3) To make recommendations to the General Assembly, the
- Governor, and the public as to the most efficient and
- 19 economical method the home district assistant may employ to
- 20 save taxpayers dollars.
- 21 (4) To evaluate, at least once a Legislation session,
- the overall performance of the home district assistants.
- 23 Section 5. Membership of Committee. -- The Home District
- 24 Assistant Advisory Committee shall consist of:
- 25 (1) At least one officer of a Statewide organization
- 26 established to promote the interests of business in
- 27 Pennsylvania.
- 28 (2) At least one officer of a Statewide organization
- 29 established to promote the interests of labor in
- 30 Pennsylvania.

- 1 (3) At least one assistant of a United States Senator 2 from Pennsylvania who works in the Senator's home office.
- (4) At least one assistant of a United States
 Congressman from Pennsylvania who works in the Congressman's
- 6 (5) At least one officer of the Statewide organization 7 established to promote the interests of Pennsylvania farmers.
- 8 (6) At least one officer of a Statewide organization 9 established to promote the interests of Pennsylvania bankers.
- 10 (7) At least one officer of a Statewide organization 11 established to promote the interests of Pennsylvania 12 colleges.
- 13 (8) At least one professor of political science at a
 14 Pennsylvania college or university who has published at least
 15 one book on state legislators in the United States or at
 16 least one book on the Pennsylvania legislators.
- 17 (9) At least one former Governor of Pennsylvania or one 18 former Lieutenant Governor of Pennsylvania.
- 19 (10) At least one officer of a Statewide women's organization.
- 21 (11) At least one officer of a Statewide organization 22 interested in improving the character and habits of 23 Pennsylvania citizens.
- 24 (12) At least one officer of a Statewide religious 25 organization.
- 26 (13) At least one officer of a Statewide organization of 27 Pennsylvania news media.
- 28 (14) At least one member of the State House.
- 29 (15) At least one member of the State Senate.
- 30 (16) At least one officer of a Statewide organization

- 1 seeking to reduce governmental expenditures.
- 2 (17) At least one officer of a Statewide organization
- 3 established to advance the interests of lawyers.
- 4 (18) At least one officer of a Statewide organization
- 5 established to advance the interests of health care.
- 6 (19) At least one officer of a Statewide organization
- 7 established to advance the interests of State employees.
- 8 Section 6. Time of Appointment; Terms.--(a) Members of the
- 9 Home District Assistant Advisory Committee shall be appointed
- 10 within 60 days of the passage of this act. They shall serve for
- 11 three years, or as long as they hold required qualifications for
- 12 their position on the Home District Assistant Advisory
- 13 Committee, whichever is shorter.
- 14 (b) The Home District Assistant Advisory Committee shall
- 15 meet at least six times a year with additional meetings to be
- 16 called by the chairman or by a filed request of one-third of the
- 17 members.
- 18 Section 7. Appropriation. -- The sum of \$2,277,000 is hereby
- 19 specifically appropriated to the General Assembly to carry out
- 20 the purposes of this act.
