1 2 3 4 5 6 7 8 9 10	Amending the act of July 15, 1976 (No.204), entitled "An act implementing the provisions of Article V of the Constitution of Pennsylvania relating to district justices; establishing magisterial districts; setting salaries and expenses; providing for certain education requirements; fixing jurisdiction; creating an administrator for district justices and imposing powers and duties on such administrator; requiring certain liability insurance; and making repeals," providing for the payment of all costs in motor vehicle cases to the county.

14	as the "Magisterial District Reform Act," is amended to read:

17	be paid monthly to the Commonwealth in amounts as prescribed in
18	subsection (b), and the balance, together with all costs
19	collected from motor vehicle cases, shall be paid monthly to the
20	county in which the magisterial district is located. Costs paid
21	to the Commonwealth shall be credited to the General Fund. Costs
22	paid to the county shall be retained by the county for its use.
