- 9 WHEREAS, The administration of public and medical assistance

- 2 Welfare pursuant to the provisions of the "Public Welfare Code,"
- 3 therefore be it
- 4 RESOLVED (the Senate concurring), That the House of
- 5 Representatives and the Senate of the Commonwealth of
- 6 Pennsylvania direct their respective Health and Welfare and
- 7 Public Health and Welfare Committees to immediately review the
- 8 "Public Welfare Code" and make recommendations to their
- 9 respective bodies of the General Assembly for the improvement of
- 10 the efficiency and accountability of public and medical
- 11 assistance in Pennsylvania and the performance of those services
- 12 for the benefit of the people of Pennsylvania.
