1 2 3 4 5 6	To the act of July 28, 1966 (3rd Sp.Sess., P.L.87, No.3), entitled "An act providing for the establishment and operation of the University of Pittsburgh as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the
7	composition of the board of trustees; terms of trustees, and
8 9	the power and duties of such trustees; authorizing appropriations in amounts to be fixed annually by the General
10	Assembly; providing for the auditing of accounts of
11	expenditures from said appropriations; providing for public
12 13	support and capital improvements; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring

15	the University of Pittsburgh," making appropriations for
16 17	carrying the same into effect, providing for a basis for payments of such appropriations, and providing a method of
1 / 18	accounting for the funds appropriated.
19	The General Assembly of the Commonwealth of Pennsylvania
20	hereby enacts as follows:
21	Section 1. The following sums, or as much thereof as may be
22	necessary, are hereby specifically appropriated to the Trustees
23	of the University of Pittsburgh for the fiscal year July 1, 1975
24	to June 30, 1976, for the purpose and in the amounts as shown:
25	(1) For net cost of instruction excluding
26	Doctor of Medicine\$51,292,000

- 1 (2) For net cost of student aid...... 2,960,000
- 2 (3) For instruction Doctor of Medicine
- 4 Section 2. Payments to the University of Pittsburgh on
- 5 account of the appropriations for all items, as provided in
- 6 section 1 except for instruction Doctor of Medicine shall be
- 7 made on the basis of net costs during the fiscal year.
- 8 Payments for instruction Doctor of Medicine shall be made
- 9 on the basis of full-time equivalent student enrollment at the
- 10 rate of \$7,465 per student.
- 11 Section 3. If necessary the University of Pittsburgh may
- 12 transfer funds between the appropriations listed in section 1,
- 13 clauses (1) and (2): Provided, That the aggregate amount
- 14 transferred into or out of each appropriation during the fiscal
- 15 year shall not exceed 5% of the amount specifically appropriated
- 16 for that purpose.
- 17 Section 4. There shall be no further disbursement of funds
- 18 appropriated for the University of Pittsburgh after September
- 19 30, 1975, until the chairpersons of the House and Senate
- 20 Appropriations Committees and the chairpersons of the House and
- 21 Senate Education Committees have received copies of letters
- 22 notifying at least a 5% reduction of the current full-time
- 23 faculty members or full-time equivalent faculty members, and at
- 24 least a 5% reduction of the current administrators and one vice-
- 25 president at the university as of September 1, 1976. When the
- 26 chairpersons of the respective committees have received proof of
- 27 reduction notification they shall then notify the Treasurer of
- 28 the Commonwealth who may authorize disbursements from
- 29 appropriated funds to the university.
- 30 As an additional condition precedent to the disbursement of

- 1 appropriated funds after September 30, 1975 to the university,
- 2 the university shall furnish satisfactory evidence to the
- 3 chairpersons of the House and Senate Appropriations Committees
- 4 and the chairpersons of the House and Senate Education
- 5 Committees that, commencing with the academic year that begins
- 6 in September 1975, all programs of academic fee remission and
- 7 tuition waiver for all employees of the university are
- 8 abolished.
- 9 Section 5. Payments to the University of Pittsburgh of the
- 10 appropriations herein provided shall be made monthly during the
- 11 fiscal year.
- 12 Such monthly payments shall be made in accordance with the
- 13 provisions of section 2 on the basis of estimated net costs and
- 14 full-time equivalent students enrolled in the Doctor of Medicine
- 15 program. The estimate of net costs shall be submitted by the
- 16 University of Pittsburgh to the Secretary of Education, the
- 17 General Assembly and to the Treasurer of the Commonwealth not
- 18 later than 30 days prior to the date on which such payment is to
- 19 be made.
- 20 Section 6. The University of Pittsburgh shall apply the
- 21 moneys appropriated by this act only for such purposes as are
- 22 permitted in this act and shall at all times maintain proper
- 23 records showing the application of such moneys. Not later than
- 24 120 days after the close of the fiscal year to which this act
- 25 relates, the University of Pittsburgh shall file with the
- 26 Secretary of Education, the General Assembly and with the
- 27 Auditor General of the Commonwealth, a statement setting forth
- 28 the amounts and purposes of all expenditures made from moneys
- 29 appropriated by this act and other university accounts during
- 30 said fiscal year, the number of full-time equivalent students

- 1 enrolled in the Doctor of Medicine program and net costs, as
- 2 provided in section 2, used as a basis for receipt of any
- 3 appropriation during said fiscal year.
- 4 Such statement of expenditures, and number of full-time
- 5 equivalent students enrolled in the Doctor of Medicine program
- 6 and net costs shall be reviewed by the Auditor General of the
- 7 Commonwealth, and he shall have the right, in respect to the
- 8 moneys appropriated by this act, to audit and disallow
- 9 expenditures made for purposes not permitted by this act and to
- 10 cause such sums to be recovered and paid by the University of
- 11 Pittsburgh to the Treasurer of the Commonwealth. The Auditor
- 12 General shall also make a determination of full-time equivalent
- 13 students enrolled in the Doctor of Medicine program and net
- 14 costs and make a certification as to their correctness. In
- 15 respect to expenditures made by the university from moneys other
- 16 than those appropriated by this act, the Auditor General shall
- 17 have the right to review only and he shall file annually with
- 18 the General Assembly such information concerning such
- 19 expenditures as the General Assembly or any of its committees
- 20 may require.
- 21 Section 7. A report shall be submitted to the Governor and
- 22 the Appropriations and Education Committees of the Senate and
- 23 House of Representatives and shall include data for all programs
- 24 of the university except the Doctor of Medicine program. The
- 25 report, to be submitted prior to November 1, 1976, shall cover
- 26 the twelve-month period beginning September 1, 1975. The report
- 27 shall include for each term during the period:
- 28 (1) The following counts and distributions:
- 29 (i) The definitions and numbers of full-time faculty
- 30 members, of part-time faculty members, of full-time students

- 1 enrolled in graduate courses, of full-time students enrolled in
- 2 undergraduate courses, of part-time students enrolled in
- 3 graduate courses, and of part-time students enrolled in
- 4 undergraduate courses.
- 5 (ii) A distribution of part-time faculty members by the
- 6 percentage of full-time employment.
- 7 (iii) Total numbers of undergraduate student credit hours,
- 8 divided into lower division and upper division levels, and of
- 9 graduate student credit hours divided into three levels--
- 10 master's, first professional and doctoral.
- 11 (iv) Number of different courses scheduled by level of
- 12 instruction, distributed by the number of sections scheduled in
- 13 each course and the sections distributed by the number of
- 14 students enrolled in each section.
- 15 (v) Number of terms scheduled and the dates thereof.
- 16 (2) A classification of faculty members or other
- 17 professional employees by title including: professor, associate
- 18 professor, assistant professor, instructor, lecturer, research
- 19 associate, librarian, and academic administrator; faculty
- 20 members or other professional employees under each title to be
- 21 subdivided by type of assignment: undergraduate courses only,
- 22 graduate courses only, or both graduate and undergraduate
- 23 courses; and each such set of faculty members or other
- 24 professional employees to be further subdivided by type of
- 25 employment: full-time or part-time; and the following aggregates
- 26 for each such subdivided classification:
- 27 (i) The number.
- 28 (ii) The sum of credits assigned to undergraduate courses
- 29 and the sum of credits assigned to graduate courses taught,
- 30 divided into lower division, upper division, master's, first

- 1 professional and doctoral levels.
- 2 (iii) The sum of undergraduate student credit hours and the
- 3 sum of graduate student credit hours generated; divided into
- 4 lower division, upper division, master's, first professional and
- 5 doctoral levels.
- 6 (iv) Total salary paid.
- 7 (v) Total salary paid from university funds.
- 8 (vi) Total salary paid from Federal funds.
- 9 (vii) Total salary paid from other funds.
- 10 (3) For each term of the period covered for each full-time
- 11 faculty member identified by school, department and title:
- 12 (i) An analysis of the average hours per week spent in
- 13 university-related activities, stating specifically hours spent
- 14 in undergraduate classroom contact and graduate classroom
- 15 contact, hours spent in preparation, hours spent in research and
- 16 hours spent in public service.
- 17 (ii) The total salary paid and the salary paid from
- 18 university funds.
- 19 Section 8. In addition to the requirements of section 7, the
- 20 report covering the twelve-month period beginning September 1,
- 21 1975, shall include for all programs of the university except
- 22 the Doctor of Medicine program:
- 23 (1) Minimum number of credits required for a baccalaureate
- 24 degree, and for a master's degree.
- 25 (2) Number of bachelor's degrees, master's degrees, first
- 26 professional degrees, and doctoral degrees awarded in 1973, 1974
- 27 and 1975 and estimated 1976.
- 28 Section 9. The university shall report its revenues and
- 29 expenditures and present its financial statements required under
- 30 the provisions of this act in accordance with generally accepted

- 1 accounting principles and procedures for educational
- 2 institutions as set forth in "Industry Audit Guide for Colleges
- 3 and Universities" of the American Institute of Certified Public
- 4 Accountants of 1973, without exception.
- 5 Section 10. This act shall take effect July 1, 1975.
